Galecron SP + Tank Mixtures: Add 2/3 of the required amount of water to the spray or mixing tank. With the agitator running if possible, drop in the required number of unopened 2 1/2 lb. soluble bags of Galecron SP in the tank. Then add the desired amount of the other products recommended on the Galecron SP label. Continue agitation while adding the remainder of water. If mixing is done in a separate mixing tank, the Galecron SP tank mixtures must be transferred to the sprayer tank by a closed system.

Read and follow all directions and precautions that appear on the full product label. This labeling must be in possession of the user at the time of use.
