Hazards to Humans and Domestic Animals

Fatal if swallowed, inhaled or absorbed through skin or eyes. Causes eye damage and skin irritation. Do not get in eyes, on skin or clothing. Do not breathe vapors. If in eyes: flush eyes with plenty of water and get medical attention.

If inhaled: move to fresh air. If not breathing, give artificial respiration, preferrably mouth-to-mouth unless exposure was from swallowing, then use other means. If breathing is difficult give oxygen. Get medical attention.

Methidathion is a cholinesterase inhibitor. Atropine is antidotal and should be given as early poisoning symptoms appear. 2-PAM is also antidotal and may be administered in conjunction with atropine. If swallowed, lavage stomach taking care to avoid aspiration of stomach contents into lungs. Instill 30 to 50 gm. slurry of activated charcoal in water into the stomach after lavage.
