Bicep 4.5L is a selective herbicide recommended as a preplant surface-applied, preplant incorporated, preemergence, postemergence broadcast or postemergence-directed treatment for control of most annual grasses and broadleaf weeds in corn (field corn, silage corn, sweet corn, or popcorn) and as a preplant surface-applied, preplant incorporated, or preemergence treatment for control of most annual grasses and broadleaf weeds in grain or forage sorghum provided the sorghum seed has been properly treated by the seed company with Concep®. This product may be tank mixed with Bladex® (4L, 80W, 90WDG), Dual® formulations, AAtrex® 4L (80W, Nine-O®), or Princep® 4L (80W or Caliber® 90)

for weed control in conventional tillage corn. This product may also be tank mixed with either Gramoxone® Extra or Roundup® alone or in combination with AAtrex, Bladex, Dual or Princep, in minimum-tillage or no-tillage corn, or tank mixed with either Gramoxone Extra or Roundup, in minimum-tillage or no-tillage sorghum.

Following many years of continuous use of atrazine (one of the ingredients in Bicep 4.5L), and products chemically related to atrazine, biotypes of some of the weeds listed on this label which are controlled by the atrazine component have been reported to develop resistance to this and chemically related herbicides. Where this is known or suspected and weeds controlled by this product are expected to be present along with resistant biotypes, we recommend the use of Bicep 4.5L in combination or in sequence with registered herbicides which do not contain triazines. Consult with your State Agricultural Extension Service for specific recommendations.

<u>Frecautions: 1)</u> sorghum seed is not properly pretreated with Concep, Bicep 4.51 will severely injure the crop. 2) Injury may occur to corn or sorghum following the use of Bicep 4.5L under abnormally high soil moisture conditions during early development of the crop.

Bicep 4.5L alone or in tank mixture with AAtrex, Bladex, Dual, or Princep may be applied preplant incorporated, preplant surface, or preemergence on corn in water or fluid fertilizer. Bicep 4.5L may be applied in tank mix combination with Gramoxone Extra or Roundup with or without the above herbicides preplant surface or preemergence to corn. Apply the early postemergence treatment on corn in water only. Bicep 4.5L alone may also be applied on sorghum preplant incorporated, preplant surface, or preemergence in water or in fluid fertilizer.

Bicep 4.5L may be applied in water by aircraft. Applications in fluid fertilizer should be only by ground equipment.

To avoid spray drift, do not apply under windy conditions. Avoid spray overlap, as crop injury ma result.

Do not apply this product through any type of irrigation system.

Mixing Instructions

}

Shake well before using. Bicep 4 5L is a liquid that may be mixed with water or fluid fertilizer and applied as a spray. Bicep 4.5L may also be sprayed onto dry bulk granular fertilizer and applied with the granular fertilizer.

Dry Bulk Granular Fertilizers

Many dry bulk granular fertilizers may be impregnated or coated with Bicep 4.5L and used to control weeds in corn or Concep-treated sorghum.

When applying Bicep 4.5L with dry bulk granular fertilizers, follow all directions for use and precautions on the Bicep 4.5L label regarding target crops, rates per acre, soil texture, application methods, and rotational crops.

All individual state regulations relating to dry bulk granular fertilizer blending, registration, labeling, and application are the responsibility of the individual and/or company selling the herbicide/fertilizer mixture.

Prepare the herbicide/fertilizer mixture by using any closed drum, belt, ribbon, or other commonly used dry bulk fertilizer blender. Nozzles used to spray Bicep 4.5L onto the fertilizer must be placed to provide uniform spray coverage.

If the herbicide/fertilizer mixture is too wet, use a highly absorptive powder, such as Microcel E (Johns-Manville Products Corporation), diatomaceous earth or finely powdered clay, to obtain a dry free-flowing mixture. Add the absorptive powder separately and uniformly to the herbicide/fertilizer mixture and blend to form a suitable free-flowing mixture. Generally, less than 2% by weight of absorptive powder will be needed.

Calculate the amount of Bicep 4.5L to be used by the following:

Precautions: To avoid potential tor explosion, (1) Do not impregnate Bicep 4.5L on ammonium nitrate, potassium nitrate, or sodium nitrate either alone or in blends with other fertilizars. (2) Do not combine Bicep 4.5L with a single superphosphate (0-20-0) or treble superphosphate (0-46-0). (3) Do not use Bicep 4.5L on straight limestone, since absorption will not be achieved. Fertilizer blends containing limestone can be impregnated.



Application

Apply 200-700 pounds of the herbicide/fertilizer mixture per acre. For best results, apply the mixture uniforrly to the soil with properly calibrated equipment immediately after blending. Uniform application of the herbicide/fertilizer mixture is essential in order to prevent possible crop injury or injury to subsequent rotational crops. Non-uniform application may also result in unsatisfactory weed control. In areas where conventional tillage is practiced, a shallow incorporation of the mixture into the soil is recommended to obtain satisfactory weed control. On fine or medium-textured soils in areas where soil incorporation is not planned, i.e., reduced tillage situations or in some conventional till situations, make applications approximately 30 days before planting to allow moisture to move the herbicide/fertilizer mixture into the soil. On coarsetextured soils, make applications approximately 14 days prior to planting.

<u>Precautions: (1) To help avoid rotational crop injury, make</u> <u>applications as early as possible, since Bicep 4.5L impregnated</u> <u>onto dry bulk granular fertilizers can be expected to last</u> <u>longer in the soil than when Bicep 4.5L is applied as a spray in</u> <u>water or fluid fertilizer. (2) Do not use on crops where bed-</u> <u>ding occurs, or crop injury may occur</u>.

Application in Water or Fluid Fertilizers

<u>Bicep 4.5L Alone</u>: Fill the spray tank one-half to three-fourths full with water or fluid fertilizer, add the proper amount of Bicep 4.5L, then add the rest of the water or fluid fertilizer. Provide sufficient agitation during mixing and application to maintain a uniform suspension.

<u>Tank Mixtures</u>: Fill the spray tank one-half to three-fourths full with water or fluid fertilizer, add the proper amount of Bicep 4.5L, then add AAtrex, Banvel, linuron, or Princep; next add Dual; then Gramoxone Extra or Roundup, depending on the tank mix combination desired; and finally add the rest of the water or fluid fertilizer. When Bladex is used in the tank mixture, add it before Bicep 4.5L unless otherwise specified. (See Bladex section under <u>Bicep 4.5L Combinations-Corn</u> for further mixing instructions.) Provide sufficient agitation during mixing and application to maintain a uniform suspension.

<u>Compatibility Test</u>: Check the compatibility of Bicep 4.5L and tank mixtures in fluid fertilizer by mixing proportionate quantities in a small container, as described below, before mixing in the spray tank. Nitrogen solutions or complete fluid fertilizers may replace all or part of the water in the spray. Since liquid fertilizers can vary, even within the same analysis, <u>always check compatibility each time before reuse</u>. Be especially careful when using <u>complete</u> suspension or fluid

fertilizers as serious compatibility problems are more apt to occur. Commercial application equipment may improve compatibility in some instances. The following test assumes a spray volume of 25 gals. per acre. For other spray volumes, make appropriate changes in the ingredients. Check compatibility using this procedure:

- 1) Add 1 pirt of fertilizer to each of 2 one-quart jars with tight lids.
- 2) To <u>one</u> of the jars add 1/4 tsp. or 1.2 milliliters of a compatibility agent approved for this use, such as Compex® or Unite® (1/4 tsp. is equivalent to 2 pts. per 100 gals. spray). Shake or stir gently to mix.
- 3) To <u>both</u> jars add the appropriate amount of herbicide(s). If more than one herbicide is used, add them separately with dry herbicides first, flowables next, and emulsifiable concentrates last. After each addition, shake or stir gently to thoroughly mix. The appropr ate amount of herbicides for this test follows:

Dry herbicides: For each pound to be applied per acre add 1.4 teaspoons to each jar. Liquid herbicides: For each pint to be applied per acre add 0.5 teaspoon or 2.5 milliliters to each jar.

4) After adding all ingredients, put lids on and tighten, and invert each jar ten times to mix. Let the mixtures stand 15 minutes and then look for separation, large flakes, precipitates, gels, heavy oily film on the jar, or other signs of incompatibility. Determine if the compatibility agent is needed in the spray mixture by comparing the two jars. If either mixture separates, but can be remixed readily, the mixture can be sprayed as long as good agitation is If the mixtures are incompatible, test the following used. methods of improving compatibility: (A) slurry the dry herbicide(s) in water before addition, or (B) add 1/2 of the compatibility agent to the fertilizer and the other 1/2 to the emulsifiable concentrate or flowable herbicide before addition to the mixture. If still incompatible, do not use the mixture.

Application Procedures

<u>Ground Application</u>: Use sprayers that provide accurate and uniform application. Screens in nozzles and in suction and in-line strainers should be no finer than 50-mesh. Use a pump with capacity to (1) maintain 35-40 psi at the nozzles, and (2) provide sufficient agitation in tank to keep mixture in suspension. Unless otherwise specified, use a minimum of 10 gals. of spray mixture per acre. Rinse sprayer thoroughly with clean water immediately after use.


For band applications, calculate amount to be applied per acre as follows:

<u>Aerial Application</u> (for Bicep 4.5L alone): Use aerial application only where broadcast applications are specified. Apply a minimum of 1 gal. of water for each 1 gal. of this product applied per acre, but for rates below 1 gal./acre, use in sufficient water to equal 2 gals./acre of total spray. Avoid applications under conditions where uniform coverage cannot be obtained or where excessive spray drift may occur. In order to assure that spray will be controllable within the target area when used according to label directions, make applications at a maximum height of 10 ft., using low drift nozzles at a maximum pressure of 40 psi, and restrict application to periods when wind speed does not exceed 10 mph. To assure that spray will not adversely affect adjacent sensitive nontarget plants, apply Bicep 4.5L by aircraft at a minimum upwind distance of 400 ft. from sensitive plants.

Avoid application to humans or animals. Flagmen and loaders should avoid inhalation of spray mist and prolonged contact with skin, and should wash thoroughly before eating and at the end of each day's operation.

Within rate ranges in all tables on this label, use the lower rate on soil relatively coarse-textured or low in organic matter; use the higher rate on soil relatively fine-textured or high in organic matter.

*Control of these weeds can be erratic especially under dry weather conditions. Control escaped weeds with cultivation or application of an appropriate EPA-registered postemergence herbicide. On fine-textured soils, only partial control can be expected.

- **Control may be improved by following these suggested procedures:
- <u>Thoroughly till moist soil</u> to destroy germinating and emerged weeds. If Bicep 4.5L is to be applied preplant incorporated, this tillage may be used to incorporate Bicep 4.5L if uniform 2 inch incorporation is achieved as recommended under <u>Application Procedures</u>.
- Plant crop into moist soil <u>immediately after tillage</u>. If Bicep 4.5L is to be used preemergence, apply at planting or immediately after planting.
- 3) If available, <u>sprinkler irrigate</u> within 2 days after application. Apply 1/2-1 inch of water. Use lower water volume (1/2 inch) on coarse-textured soils. Also, refer to the section on <u>Center Pivot Irrigation Application</u> for this method of applying Bicep 4.5L.
- 4) If irrigation is not possible and rain does not occur within 2 days after planting and application, weed control may be decreased. Under these conditions, a uniform, shallow cultivation is recommended as soon as weeds emerge.

Bicep 4.5L Rate Limitations - Corn and Sorghum

*Where there are state/local requirements regarding atrazine use (including lower maximum rates and/or greater set-backs) which are different from the label, the more restrictive/protective requirements must be followed. Certain states have established rate limitations within specific geographical areas. Consult your state lead pesticide control agency for additional information. It is a violation of this label to deviate from state use regulations.

FOR ALL SOIL APPLICATIONS PRIOR TO CROP EMERGENCE

On Highly Erodible Soils (as defined by SCS)

If conservation tillage is practiced, leaving at least 30% of the soil covered with plant residues at planting, apply 4 qts./A as a broadcast spray. Refer to "B" in tables following.

If the soil coverage with plant residue is less than 30% at planting, a maximum of 3.2 qts./A may be applied. Refer to "A" in tables following.

On Soils Not Highly Erodible

Apply a maximum of 4 qts./A as a broadcast spray. Refer to "B" in tables following.

FOR POSTEMERGENCE APPLICATION TO CORN

If no atrazine was applied prior to corn emergence, apply a maximum of 4 qts./A broadcast. If a postemergence treatment is required following an earlier herbicide application, the total atrazine applied may not exceed 2.5 lbs. active ingredient (5 qts. of Bicep 4.5L) per acre per calendar year.

Preplant Surface Applied (Corn): Use on medium- and finetextured soils with minimum-tillage or no-tillage systems in CC, IN, IL, IA, KS, KY, MN, MO, MT, NE, ND, SD, TN, WI, and WY. Apply 2/3 the recommended rate of Bicep 4.5L (3.2-4 qts./A on medium <u>soils</u> and 4 qts. on fine soils) as a split treatment 30-45 days before planting and the remainder at planting. Applications made less than 30 days prior to planting may be as either a split or single treatment. Use the lower rate for light expected weed infestations and the higher rate for heavy expected weed infestations. On <u>coarse-textured</u> soils, apply 3.2 qts./A not more than 2 weeks prior to planting. The above procedure also may be followed if AAtrex or Dual 8E or Princep is used in tank mixtures with Bicep 4.5L. If weeds a 2 present at the time of treatment, apply in a tank mixture combination with a contact herbicide (for example, Gramoxone Extra or Roundup). Observe directions for use, precautions, and restrictions on the label of the contact herbicide.

On medium and fine-textured soils with minimum or no-tillage systems in DE, MD, MI, NY, OH, PA, VA, and WV, preplant surface applications may be applied following the directions for use abov3. If the amount of rainfall results in unsatisfactory length of weed control following the earlier treatment, a postemergence application of an appropriately labeled broadleaf and/or grass weed herbicide may be used, i.e., AAtrex, Basagran®, 2,4-D, Banvel®, bromoxynil (Brominal® or Buctril®). If the postemergence treatment includes the herbicide used preplant surface-applied, do not exceed the labeled rate for corn on a given soil texture. Observe all directions for use, precautions and limitations on the label of the postemergent herbicide.

<u>Note</u>: To the extent possible, do not move treated soil out of the row or move untreated soil to the surface during planting, or weed control will be diminished.

<u>Preplant Surface-Applied (Sorghum-Seed Treated with Concep)</u>: For minimum-tillage and no-tillage systems only, Bicep 4.5L may be applied up to 45 days before planting grain sorghum in IL, IA, eastern KS, MO, NE, and SD. Use only split applications for treatments made 30 to 45 days before planting with 2/3 the recommended rate applied initially and the remaining 1/3 at planting. On medium soils with greater than 1.5% organic matter, and on fine soils with less than 1.5% organic matter, apply 3.2-3.6 qts./A of Bic p 4.5L; on fine soils with greater than 1.5% organic matter, apply 3.6-4 qts./A of Bicep 4.5L. Applications made less than 30 days prior to planting may be as either a split or a single application.

If weeds are present at the time of treatment, apply in a tank mixture combination with a contact herbicide (for example, Gramoxone Extra or Roundup). Observe directions for use, precautions, and restrictions on the label of the contact herbicide. Under dry conditions, irrigation after application is recommended to move Bicep 4.5L into the soil. Use of low rates on fine soils may result in reduced control of certain broadleaf weeds.

Note: To the extent possible, do not move treated soil out of the row or move untreated soil to the surface during planting, or weed control will be diminished. Do not use on coarse soils. Do not use on medium soils with less than 1.5% organic matter.

<u>Preplant Incorporated or Preemergence (Corn or Sorghum-Seed</u> <u>Treated with Concep</u>): Apply Bicep 4.5L preplant incorporated or preemergence using the appropriate rates from Table 1 for corn, or from Table 2 for sorghum.

<u>Preplant Incorporated</u>: Apply to the soil and incorporate into the top 2 inches of the soil within 14 days prior to planting using a finishing disk harrow, rolling cultivator, or similar implement capable of providing uniform 2-inch incorporation. Use preplant incorporated if furrow irrigation is used or when a period of dry weather after application is expected. If crop is to be planted on beds, apply and incorporate after bed formation.

<u>Preemergence</u>: Apply to the soil surface at planting (behind the planter), or after planting but before weeds or crop emerge.





Users are advised not to apply atrazine to sand and loamy sand soils where the water table (ground water) is close to the surface and where these soils are very permeable, i.e., well-drained. Your local agricultural agencies can provide further information on the type of soil in your area and the location of ground water.

Metolachlor has been identified in limited sampling of ground water and there is the possibility that it may leach through the soil to ground water, especially where soils are coarse and ground water is near the surface. Following application and during rainfall events that cause runoff, metolachlor may reach surface water bodies including streams, rivers, and reservoirs.
