GENERAL INFORMATION

TANZINE Granules is an effective general herbicide for the control of many annual and perennial weeds, grasses, brush and trees. Apply to non-crop land areas; e.g., railroad and pipeline rights-of-way, petroleum tank farms, lumberyards, storage areas, industrial plant sites, around silos, barns and other farm buildings. Effects may not become apparent until the chemical has been carried into the root zones by moisture. The degree of control and duration of effect will vary with the amount of chemical applied, soil type, rainfall and other conditions.

DIRECTIONS FOR USE

TANZINE Granules should be distributed uniformly over the area to be treated using a cyclone spreader or other suitable equipment. For small areas, application by hand may be adequate. Apply TANZINE Granules just before or during the period of active growth of the weeds to be controlled.

Apply 150 to 225 pounds per acre (3½ to 5 pounds per 1000 square feet) to control annual and perennial grasses and weeds such as barnyard grass, bindweed, bluegrass, brambles, bromegrass, clovers, common yarrow, crabgrass, dandelion, dog fennel, docks, fiddleneck, foxtail, goldenrod, horsetail, lambsquarters, milkyweed, orchardgrass, pigweed, plantain, puncturevine, purpletop, ragweed, redtop, teasel, thistles, turkymullein, wild turkey, wild carrot, yellow toad flax.
