Subject: Amendment- Add Inadvertent Use on Oats Ridomil 2E Fungicide EPA Registration # 100-607 Your Submission Dated October 30, 1989

The Agency is conditionally approving an amendment to the registration of the above-referenced product under the authority of section 3(c)7(b) of the Federal Insecticide, Fungicide and Rodenticide Act. This amendment allows the indirect/inadvertent use of the subject product on oat grain, oat forage, oat fodder, oat straw, processed food item oat milling fractions and processed feed item oat milling fractions. It will be subject to the conditions listed below. To maintain your registration you must:

- 1. Submit the data required by the deadlines listed below, from the studies conducted in accordance with the Good Laboratory Practice regulations, 40 CFR Part 160, and the appropriate test guidelines as referenced in EPA's data requirements for Registration Regulation, 40 CFR PART 158. Groundwater Monitoring Study- Due Date: April 1,1993
- Submit/cite all data required for registration/ reregistration of your product under FIFRA section
  (c) (5) when the Agency requires all registrants of similar products to submit such data.
- 3. Submit production information (pounds or gallons produced) for this product for the fiscal year in which this use is conditionally registered, in accordance with FIFRA section 29. The fiscal year begins October 1 and ends September 30. The product information will be submitted to the Agency no later than November 15, following the end of the preceding fiscal year.

You should note that if you fail to satisfy any of the conditions imposed on this registration, e.g., you fail to submit the required data by the specified deadlines or the data submitted were not generated in accordance with the applicable test guidelines, EPA may issue a notice to cancel this amendment under FIFRA section 6 (e) .
