Dear Dr. Rezaaiyan:

The revised amended label referred to above, submitted February 22, 2009 in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable provided the following changes are made:

1. On page 2 in the section **Hazards to Humans and Domestic Animals** change "...chewing gum or using tobacco." to "...chewing gum, using tobacco, or using the toilet."
2. On pages 4 and 5 it is recommended that you put the **STORAGE AND DISPOSAL** instructions into a text box to set them off from the rest of the text.

One copy of the label stamped "Accepted with comments" is enclosed for your records. Please submit one copy of the final printed label that incorporates the required changes before the product is released for shipment.
