Shake well before using. Bicep 4.5L is a liquid that may be mixed with water or fluid fertilizer and applied as a spray. Bicep 4.5L may also be sprayed onto dry bulk granular fertilizer and applied with the granular fertilizer.

# Dry Bulk Granular Fertilizers

Many dry bulk granular fertilizers may be impregnated or coated with Bicep 4.5L and incorporated into the soil to control weeds in corn.

Labels, supplementary literature, and precautions regarding rates per acre, approved crops, soil texture, application, incorporation, crop rotat'on and other directions must be followed for Bicep 4.5L.

All individual state regulations relating to dry bulk granular fertilizer blending, registration, labeling and application are the responsibility of the individual and/or company selling the herbicide/fertilizer mixture.

Apply 200-700 pounds per acre of dry granular fertilizer impregnated with Bicep 4.5L.

Compatibility Test: Check the compatibility of Bicep 4.5L and tank mixtures in fluid fertilizer by mixing proportionate quantities in a small container, as described below, before mixing in the spray tank. Nitrogen solutions or complete fluid fertilizers may replace all or part of the water in the spray. Since liquid fertilizers can vary, even within the same analysis, always check compatibility each time before reuse. Be especially careful when using complete suspension or fluid fertilizers as serious compatibility problems are more apt to occur. <u>Dry herbicides</u>: For each pound to be applied per acre, add 1.4 teaspoons to each jar.

Liquid herbicides: For each pint to be applied per acre add 0.5 teaspoon or 2.5 milliliters to each jar.

4) After adding all ingredients, put lids on and tighten, and invert each jar ten times to mix. Let the mixtures stand 15 minutes and then look for separation, large flakes, precipitates, gels, heavy oily film on the jar, or other signs of incompatibility. Determine if the compatibility agent is needed in the spray mixture by comparing the two If either mixture separates, but can be remixed jars. readily, the mixture can be sprayed as long as good agitation is used. If the mixtures are incompatible, test the following methods of improving compatibility: (A) slurry the dry herbicides(s) in water before addition, or (B) add 1/2 of the compatibility agent to the fertilizer and the other 1/2 to the emulsifiable concentrate or flowable herbicide before addition to the mixture. If still incompatible, do not use the mixture.

<u>Ground Application</u>: For uniform distribution, use fan-type nozzles. Screens in nozzles and in suction and in-line strainers should be no finer than 50-mesh. Use a pump with capacity to (1) maintain 35-40 psi at the nozzles, and (2) provide sufficient agitation in tank to keep mixture in suspension. Unless otherwise specified, use a minimum of 10 gals. of spray mixture per acre. Rinse sprayer thoroughly with clean water immediately after use.

# Storage and Disposal

# Storage

Ground water contamination may be reduced by diking and flooring of permanent liquid bulk storage sites with an impermeable material.

# Ground Water and Surface Water Advisory

Bicep 4.5L contains both the active ingredients atrazine and metolachlor.

Atrazine can travel (seep or leach) through soil and can enter ground water which may be used as drinking water. Atrazine has been found in ground water. Users are advised not to apply atrazine to sand and loamy sand soils where the water table (ground water) is close to the surface and where these soils are very permeable, i.e., well-drained. Your local agricultural agencies can provide further information on the type of soil in your area and the location of ground water.

Metolachlor has been identified in limited sampling of ground water and there is the possibility that it may leach through the soil to ground water, especially where soils are coarse and ground water is near the surface.
