

Subject: Amended Labeling Ridomil M258 Fungicide EPA Registration No. 100-629 Your Submissions Dated February 26, 1992 and March 3, 1992

The amendments referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, are acceptable provided that you:

1. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:

a. On page 5, in the last paragraph, revise the third sentence to "For aerial application, apply in 3-10 gallons of water/acre". The phrase "are generally needed" can imply that the spray volume may be more or less than that indicated. A minimum of 2 gallons per acre is permitted by the PD4.

b. On page 6, under Ridomil MZ58 + Tank Mixtures, include only those EBDC fungicides which contain mancozeb since applications may not be made to areas where other EBDC fungicides are used. Delete "Manzate" which contains maneb. Dithane M45 and Manzate 200 both contain mancozeb and may be retained. If recommendations are retained, specific directions for use on each crop must include the maximum rate of mancozeb per application.

c. Under potatoes and tomatoes, delete tank mix recommendations for Manzace 80W and Dithane M-22 since both contain maneb.

d. For tomatoes, the tank mix directions are confusing. The statement "Do not apply more than 2 lbs./acre of (products) in combination with Ridomil MZ58" can be taken to mean 2 lbs. of (product) + 1.5 lbs. Ridomil MZ58 or to mean 2 lbs. of the

combination. This sentence must be rewritten to more clearly define the rate. If 2 lbs. of the 80% product is used, the maximum rate of mancozeb per application would be exceeded for areas west of the Mississippi River. The directions should be revised to state "When making applications of Manzate 200 or Dithane M45, use 1.0 lb. of product and 1.5 lbs. Gidomil M258 per acre every 14 days for control of late blight in aleas west of the Mississippi River or 2.0 lbs. of product and 1.5 lbs. Ridomil M258 on the same schedule for areas east of the Mississippi River." Also, in footnote (5), delete nabam and zineb since these products are no longer marketed for crop uses.

e. For specific crops add the following statement following the sentence stating maximum mancozeb limits per growing season: "If tank mixed with other products containing mancozeb, do not exceed _______ lbs. mancozeb active ingredient per acre per application." The maximum mancozeb rate/application for cucumbers, melons, squash, potatoes and sugar beets is 1.6 lbs.; for onions, 2.4 lbs. and for tomatoes, 1.6 lbs. west of the Mississippi, 2.4 lbs. east of the Mississippi.

f. On page 9, qualify the use on melons by listing the types of melons approved for mancozeb. Following melons, add "(cantaloupe, casaba, crenshaw, honeydew and watermelons)."

Submit one (1) copy of your final printed labeling before you release the product for shipment.

A stamped copy of the label is enclosed for your records.



General Information

Ridomil MZ58 contains 10% of the active ingredient metalaxyl, and 48% of the active ingredient mancozeb. Metalaxyl is a systemic fungicide for use on selected crops to control diseases caused by members of the Phycomycete family of fungi. Mancozeb is effective against a wide range of fungal pathogens.

Note: Metalaxyl is a systemic fungicide having a specific mode of action and could be subject to development of resistant strains of fungi. Development of resistance cannot be predicted. Therefore, CIBA-GEIGY cannot assume liability for crop damage resulting from resistant strains If treatment is not effective following the use of fungi. of Ridomil MZ58 as recommended, a resistant strain of fungi may be present. If the treatment is ineffective due to the presence of a metalaxyl resistant strain of fungi, neither Ridomil M258 nor any other fungicide with similar action will effectively control that disease. Consideration should then be given to the prompt use of other types of suitable fungicides. Consult with your State Agricultural Experiment Station or Extension Service Specialist for guidance in your particular crop and disease control situation. DO NOT USE RIDOMIL MZ58 FOR DISEASE CONTROL IN CROPS GROWN IN GREEN-HOUSES, LATH HOUSES, OR IN BEDDING PLANT STRUCTURES.

Mixing Instructions

Prepare no more spray mixture than is needed for the immediate operation. Thoroughly clean spray equipment before using this product. <u>Vigorous agitation is necessary to maintain tank mix</u> <u>uniformity</u>. <u>Maintain a maximum of agitation throughout the</u> <u>spraying operation</u>. Flush spray tank thoroughly with water daily after use and dispose of pesticide rinsate by application to an already treated area.

Amount of water needed per acre will vary according to the amount of plant growth. For dilute ground applications, the water volume will vary from 20-150 gals./A. For aerial applications, 3-10 gals. of water/A are generally needed. To minimize the potential of drift from target area, applications at wind speeds greater than 10 mph are not recommended. DO NOT USE LESS THAN 5 GALLONS PER ACRE IN CALIFORNIA.

Precaution: Water-soluble prepacks of Ridomil MZ58 must be completely dissolved and dispersed in water before any other tank mix partner, including micronutrients or other liquid or dry fertilizers, are added to the spray solution.

<u>Ridomil MZ58 Alone</u>: Add 2/3 of the required amount of water to the spray or mixing tank. With the agitator running, drop the required number of <u>unopened</u> soluble bags of Ridomil MZ58 into the tank all at once. Continue agitation while adding the remainder of the water. Begin application of the spray solution after the pouches have dissolved, and the material has completely dispersed into the mix water. Maintain agitation until all of the mixture has been applied.

<u>Ridomil MZ58 + Tank Mixtures</u>: Ridomil MZ58 is usually compatible with Bravo®, Dithane M-45, D·z·n®, Difolatan®, Manzate, and Manzate 200. Add 2/3 of the required amount of water to the spray or mixing tank. With the agitator running, drop the required number of <u>unopened</u> soluble bags of Ridomil MZ58 into the tank all at once. Continue agitation while adding the remainder of the water. Allow the bags of Ridomil MZ58 to dissolve and the product to completely disperse into the mix water. Then add the desired amount of other products recommended for tank mixture and allow them to become completely dispersed. Continue agitation to maintain a uniform syspension until all of the spray solution has been applied.

<u>Note</u>: Do not let spray mixture stand overnight in the spray tank. Rinse spray tank at the end of the day.

Application Through Irrigation Systems

Ridomil MZ58 alone or in combination with other fungicides which are registered for sprinkler irrigation may be applied through irrigation systems.

Apply this product only through center pivot, solid set, hand move, or moving wheel irrigation systems. Do not apply this product through any other type of irrigation system. Crop injury, lack of effectiveness, or illegal pesticide residues in the crop can result from honuniform distribution of treated water. If you have questions about calibration, you should contact State Extension Service specialists, equipment manufacturers or other experts. Do not connect an irrigation system . . . (including greenhouse systems) used for pesticide application to a public water system unless the pesticide label-prescribed safety devices for public water systems are in place. Operating Instructions:

- 1. The system must contain a functional check valve, vacuum relief valve, and low pressure drain appropriately located on the irrigation pipeline to prevent water-source contamination from backflow.
- 2. The pesticide injection pipeline must contain a functional, automatic, quick-closing check value to prevent the flow of fluid back toward the injection pump.
- 3. The pesticide injection pipeline must also contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.

Ridomil MZ58 must be applied on the schedule specified in the specific crop use recommendations, not according to the irrigation schedule. If irrigation schedules are used, ground or aerial applications must supplement chemigation applications to ... achieve adequate disease control.

With the exception of potatoes, Ridomil MZ58 has not been sufficiently tested to assure consistent product performance for all labeled uses when applied through chemigation systems. The foilowing calibration and application techniques are provided for user reference, but do not constitute a warranty of fitness for application through sprinkler irrigation equipment. Users should check with state and local regulatory agencies for potential use restrictions before applying any agricultural chemical through sprinkler irrigation equipment.

<u>Center-Fivot Irrigation Equipment</u> (Use only with drive systems which provide uniform water distribution)

- 1. Determine the size of the area to be treated.
- 2. Determine the time required to apply 1/4 inch water over the area to be treated when the system and injection equipment is operated at normal pressures recommended by the equipment manufacturer. Run the system at 80-95% of the manufacturer's rated capacity.
- 3. Using water, determine the injection pump output when operated at normal line pressure.
- 4. Determine the amount of Ridomil MZ58 required to treat the area covered by the irrigation system.

- 1. Determine the acreage covered by the sprinklers.
- 2. Fill injector solution tank with water and adjust flow rate to use the contents over a 20 to 30 minute interval.
- 3. Determine the amount of Ridomil MZ58 required to treat the area covered by the irrigation system.
- 4. Add the required number of Ridomil MZ58 soluble bags into the same quantity of water used to calibrate the injection period. (See <u>Mixing Instructions</u> section of this label.).
- 5. Operate system at the same pressure and time interval established during the calibration.
- Inject Ridomil MZ58 at the end of the irrigation cycle or as a separate application to maximize retention of the fungicide by the foliage.
- 7. Stop injection equipment after treatment is completed. Continue to operate the system under the Ridomil MZ58 solution has cleared the last sprinkler head.

Ridomil MZ58 provides effective control of downy mildew caused by <u>Pseudoperonospora</u> <u>cubensis</u> when used as a foliar spray in a preventative disease control program.

Apply 1 1/2-2 lbs. Ridomil M258 per acre in sufficient water to obtain thorough coverage. Begin applications when conditions are favorable for disease, but before infection, and continue at 14-day intervals until the threat of disease is over. Under heavy disease press re, use the higher rate of Ridomil M258.

<u>Notes</u>: (1) To minimize the potential for resistance, do nct make more than 4 applications of Ridomil MZ58 per crop. (2) If downy mildew continues to be a problem after making 4 applications of Ridomil MZ58, use other fungicides registered for downy mildew control. To avoid possible illegal residues, (3) Do not make the last application within 5 days of harvest and (4) If other registered fungicides containing <u>mancozeb</u> are used during the growing season, do not exceed a total of 19.2 lbs. of mancozeb active ingredient per acre.

Onions (Dry Bulb)

Ridomil M258 provides effective control of downy mildew caused by <u>Peronospora</u> <u>destructor</u> when used as a foliar spray in a preventative disease control program.

Apply 1 1/2-2 lbs. Ridomil M258 per acre in sufficient water to obtain thorough coverage. Begin applications when conditions are favorable for disease, but before infection, and continue at 14-day intervals until the threat of disease is over. Use a suitable spreader-sticker at rates recommended on the product label. Under heavy disease pressure, use the higher rate of Ridomil MZ58.

Notes: (1) To minimize the potential for resistance, do not make more than 4 applications of Ridomil MZ58 per crop. (2) If downy mildew continues to be a problem after making 4 applications of Ridomil MZ58, use other fungicides registered for downy mildew control. (3) Do not apply to exposed bulbs. To avoid possible illegal residues, (4) Do not make the last application within 7 days of harvest and (5) If other registered fungicides containing <u>mancozeb</u> are used during the growing season, do not

exceed a total of 24 lbs. of mancozeb active ingredient per acre.

<u>Potatoes</u>

Ridomil M258, when used as a foliar application in a preventative disease control program, will provide effective control of late blight and tuber rot caused by <u>Phytophthora infestans</u>, Pythium leak caused by <u>Pythium</u> spp, and pink rot caused by <u>Phytophthora ethroseptica</u>. Make applications of Ridomil M258 in sufficient water to obtain thorough coverage for ground applications and in a minimum of 3 gals. of water per acre for aerial applications.

It is recommended that this product be used within an Integrated Pest Management Program. Also, vine-kill should occur 14-days before harvest.

Late Blight: Apply 1 1/2-2 lbs. Ridomil M258 per acre. Begin applications when conditions are favorable for disease, but before infection, and continue at 14-day intervals until the threat of disease is over. Under heavy disease pressure, use the higher rate of Ridomil M258.

Tuber Rot, Pythium Leak and Pink Rot: Apply 2 lbs. Ridomil MZ58 per acre. Make the first application at flowering and another one 14 days later. If the field has a history of tuber disease problems, make a third application 14 days after the second application.

<u>Note</u>: If applications of Ridomil M258 are being made for late blight control that correspond to the timing of applications for tuber disease control, additional applications for tuber disease control are not needed.

For supplemental control of early blight, add 0.8 lb. of Manzate 200 80W, Dithane M-45 80W, Manzate 80W or Dithane M-22 80W to the Ridomil MZ58 spray or make an additional application of any registered early blight fungicide between each Ridomil MZ58 spray. Where early blight disease pressure is heavy, use early blight fungicides according to product use directions, and use Ridomil MZ58 only when late blight threatens. Do not apply more than 0.8 lb. per acre per application of Manzate 200 80W, Dithane M-45 80W, Manzate 80W, or Dithane M-22 80W in combination with Ridomil MZ58.

Notes: To avoid possible illegal residues, (1) Do not apply Ridomil M258 within 3 days of harvest in CT, FL, ME, MA, NH, NY, PA, VT and WI or at least 14 days elsewhere. (2) If other registered fungicides containing <u>mancozeb</u> are used during the growing season, do not exceed a total of 11.2 lbs. of mancozeb active ingredient per acre. (3) To minimize the potential for

resistance, do not make more than 4 applications of Ridomil MZ58 per crop. (4) If late blight is still a problem after making 4 applications of Ridomil MZ58, use other fungicides registered for late blight control. (5) Do not tank mix with amobam or Polyram®.

Sugar Beets

Ridomil MZ58, when used as a foliar application in a preventative disease control program, will provide effective control of downy mildew caused by <u>Peronospora</u> <u>schachtii</u>.

Apply 1-1/2 - 2 lbs. Ridomil MZ58 per acre. Begin application when conditions are favorable for disease, but before infection, and continue at 14-day intervals until the threat of disease is over. Under heavy disease pressure, use the higher rate of Ridomil MZ58.

<u>Notes</u>: (1) To minimize the potential for resistance, do not make more than four applications of Ridomil MZ58 per crop. To avoid possible illegal residues, (2) Do not make the last application within 14 days of harvest, (3) If other registered fungicides containing <u>mancozeb</u> are used during the growing season, do not exceed a total of 11.2 lbs. of mancozeb active ingredient per acre, and (4) Do not feed treated tops to livestock.

Tomatoes

Ridomil MZ58, when used as a foliar application in a preventative disease control program, will provide effective control of late blight caused by <u>Phytophthora infestans</u>.

Apply 1 1/2-2 lbs. Ridomil MZ58 per acre as a foliar spray in sufficient water to provide thorough coverage. Begin applications when conditions are favorable for disease, but before infection, and continue at 14-day intervals until the threat of disease is over. Under heavy disease pressure, use the higher rate of Ridomil MZ58.

Note: Whi conditions are favorable for development of diseases other than late blight, any registered fungicides which control those diseases may be applied according to their label direction tions. When making applications of Manzate 200, Dithane M-45, Manzate, or Dithane M-22, 1 1/2 lbs./A of Ridomil MZ58 may be added to the spray mix every 14 days for control of late blight. Do not apply more than 2 lbs. per acre per application of the Dithane M-45 80.5. Manzate 200 80W, Dithane M-22 80W, or Manzate 80W in combination with Ridomil MZ58. Plant Back Restrictions
