1. Make the labeling changes listed below before you release the product for shipment bearing the amendment labeling.
  - a. If you intend to retain the front panel statement "... for domestic outdoor use - lawns," it must be revised by deleting the term, "domestic." As presently worded, it conflicts with the statement No. 2 on page two which includes non-domestic uses.
  - b. Include a Statement of Practical Treatment for the inhalation route of exposure.
  - c. The word "POISON" must appear on the front panel in red on a background of distinctly contrasting color.
2. Submit five (5) copies of your final printed labeling before you release the product for shipment.

Storage and Disposal
