Dear Ms. Bussey:

The amendments referred to above, submitted in connection with registrations under the Federal Insecticide, Fungicide, and Rodenticide Act, are acceptable and a stamped copy of each label is enclosed for your records. The Environmental Hazards section for both of these products should be revised to be identical to that appearing on the labels for D.z.n Diazinon 1/2% EW (EPA Reg. No. 100-685) and D.z.n Diazinon 1% EW (EPA Reg. No. 100-686), which bear the same directions for outdoor home foundation spraying. As you recall, on March 29, 1990, Ecological Effects Branch shortened the Environmental Hazards text for home use products with foundation spraying as the only outdoor use to more accurately reflect wildlife exposure from such a use (comments about birds feeding on treated areas, and about shrimp and crab as resources were deleted). Specifically, the revised Environmental Hazards text should read as follows:

This pesticide is highly toxic to birds, fish, and other wildlife, including waterfowl. Keep out of lakes, streams, ponds, tidal marshes, and estuaries. Do not apply directly to water or wetlands (swamps, logs, marshes, and potheles). Do not contaminate water by disposal.

This pesticide is highly toxic to bees exposed to direct treatment or to residues on blooming plants where they feed. Do not allow this pesticide to drift to blooming plants, if bees are visiting the treatment area. Do not apply this product to or allow it to drift to food crops or any desirable vegetation at any time.

Please submit five (5) copies of the label for each of the subject products bearing the revised Environmental Hazards text, as indicated above, when they become available.

There is no need for further dilution. This product is intended for use inside the home and for limited use outside the home as a spot treatment to house foundation walls and around doors and windows for the control of those pests  $\cdot$  pecified on this label

#### INDOOR USE

#### **Controls**

Cockroaches (waterbugs), ants, silverfish, carpet beefles, spiders, scorpions, and exposed stages of sawtoothed grain theetle, flour beetle, rice weevil, cigarette beetlev daugstore beetle, and Indian meal moth

Spiders and Scorpions: Spray around windows, doors, and along baseboards. Make spot applications to other areas over which these pests may crawl.

Brown dog ticks, fleas\*: Apply thoroughly to infested areas around baseboardo, window and door frames, wall cracks, sleeping quarters of household pets, and localized areas of floors and floor coverings. Fresh bedding should be placed in animal quarters following treatment. Do not treat animals with this product. Repeat as necessary.

Pantry P. its — Exposed Stages (Sawto inhed grain beetle, flour beetle, rice iveevil, digarette beetle, drugstore beetle, Indian meal moth): Spray on shelves and in cupboards where food containers suspected of being infested are stored. Remove all food and shelving paper before spraying. Do not replace the food packages until spray has dried. Cover shelves with shelving paper. This treatment is supplemental to good housekeeping, since it will have no effect on insects breeding within food packages. Infested food packages should be destroyed.

Apply as a spot treatment to house foundation walls, around doors and windows and to other areas of the house exterior where these pests are likely to enter Repeat application as necessary. Do not spray lawns, desirable plants, or shrubbery because injury may occur.


