Mr. Pussey:

The amendments referred to above, submitted in connection with a registration under the Federal Insecticide, Fungicide, and Rodenticide Act, are acceptable provided the following revisions are made prior to release for shipment:

- 1) Delete "and outside" from the "General Information" section. You may want to emphasize the strictly indoor nature of this product by adding the word "only", so that this sentence reads "This product may only be used inside the home ...".
- 2) In number 14 of the "Precautions", revise "or other places" back to "or other areas". Re-add "Do not use in serving areas while food is exposed." at the end of item 14 of the precautions.
- 3) Because of the potential for electrical shock hazard, add the following as the last item of the "Precautions":

Do not use this product in conduits, motor housings, or electrical switch boxes.

interior of the structure and stoves, and to inspect trails and other localized areas where insects tend to move. Insects infest food packages, but do not spray inside of them where food is stored. 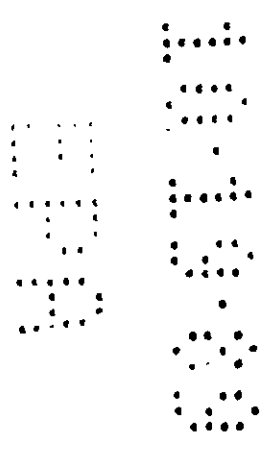

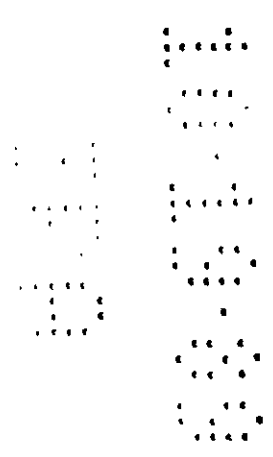

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

General Information

D-2 is 0.5 RTU is a ready to use product in a ready to use container. No mixing is required. Hold the container upright and lightly spray surfaces until wet according to the directions for use. A slight film will appear upon drying leaving residual killing power. This product may be used inside and outside the home for control of the pests specified on this label.

INDOOR USE

Controls:

Cockroaches (waterbugs), ants, firebrats, silverfish, brown dog ticks, springtails, spiders, crickets, earwigs, sowbugs (pillbugs), carpet beetles.

Precautions: 1) Do not use this product indoors as an overall surface spray or as a space spray. 2) Take care not to introduce this product into the air during application; use only in well-ventilated areas. 3) Do not apply where children are likely to frequently contact treated surfaces. 4) Remove or cover fish bowls and remove pets before application. 5) Do not treat pets or plants with this product. 6) Do not allow children or pets in treated areas until spray has dried. 7) If clothing is sprayed during application, remove clothing immediately after spraying and launder before wearing again. 8) Avoid excessive wetting of carpets or floor coverings and unfinished materials. 9) Care should be taken to avoid spotting of walls, wall coverings, and fabrics. 10) Do not apply directly to upholstery, furniture, leather, draperies, or stained surfaces because damage may occur. 11) Do not apply to areas, surfaces, or utensils which will contact food or feed. 12) Exposed food should be covered or removed during application. 13) All food processing surfaces and utensils should be covered during application or thoroughly washed with soap and water before reuse. 14) Do not use in edible product areas of food processing plants, restaurants, or other places where food or feed is commercially prepared or processed.

Application:

Cockroaches (Waterbugs), Ants, Firebrats, Silverfish Sowbugs (Pillbugs), Springtails, Spiders, Crickets, Earwigs: Spray until wet, surfaces behind and beneath cabinets, refrigerators, sinks, stoves, ant trails, and other localized areas infested with insects. Spray window and door frames where ants enter. Treat difficult to service locations such as voids around water pipes, cracks, and crevices along baseboard moldings. Repeat as necessary.

Carpet beetles: Make localized application to areas of the floor and baseboards. Spray directly into cracks and under carpets where insects may be found. Treat crevices, cracks, and infested areas of shelving in closets. Repeat as necessary.

Brown dog ticks, Fleas*: Spray infested areas around baseboards, window and door frames, wall cracks, sleeping quarters of pets, and localized areas of floors and floor coverings. Repeat as necessary. Fresh bedding should be placed in animal quarters after treatment. Do not treat animals with this product or use as an overall surface spray.

*Controls adult fleas on areas treated

Spiders: Apply spray around windows, doors, and along baseboards. Make spot applications to other areas over which these pests may crawl.

Surfaces behind and beneath cabinets: Roaches, ants, silverfish - as a supplement to good housekeeping, spray surfaces behind and beneath cabinets where insects tend to hide. Spray until wet. Do not spray inside cabinets where food is stored.

Precautionary Statements

Hazards to Humans and Domestic Animals

CAUTION

Harmful if swallowed, inhaled or absorbed through skin. Avoid breathing vapor and contact with eyes, skin and clothing. Wash thoroughly after handling and before smoking or eating. May cause contact sensitization following repeated contact with the skin of susceptible individuals. Avoid repeated contact with skin. If sensitization

reactions result, consult a physician. Remove pets from area and cover fish bowls before spraying. Keep children and pets off treated areas until the areas are dry.

Statement of Practical Treatment

If swallowed, call a physician or Poison Control Center immediately. Give milk or water. DO NOT INDUCE VOMITING unless no other treatment is available, and then preferably under medical supervision. If it is necessary to induce vomiting, give victim one or two glasses of water and insert finger in back of throat. Do not induce vomiting or give anything by mouth if person is unconscious or convulsing.

If inhaled, remove victim to fresh air and apply artificial respiration if indicated.

If on skin, wash promptly with soap and water. Rinse thoroughly.

If in eyes, rinse eyes with plenty of water. Get medical attention if irritation develops or persists.

Note to Physician: This product is an organophosphate insecticide. If signs of cholinesterase inhibition are present, gastric lavage may be indicated if product was taken internally. Atropine sulfate by injection is antidotal. 2-PAM is also antidotal and may be administered, but only in conjunction with atropine. The solvent in this product may present an aspiration hazard. Gastric lavage may be indicated if product was taken internally.

Storage and Disposal

Storage:

Keep from freezing. Store above 32°F. Store in an area inaccessible to children and pets.

Disposal:

Do not reuse empty container. Rinse container thoroughly, then wrap securely in several layers of newspaper. Discard in trash collection.
