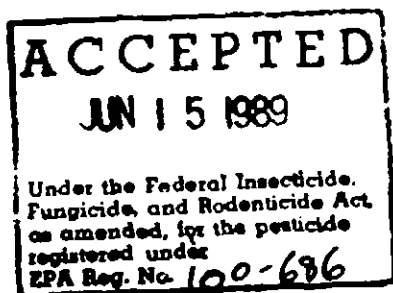

General Information

D-z-n diazinon 1% EW is a ready-to-use microemulsion product containing diazinon

There is no need for further dilution. This product is intended for use in buildings, offices, households and other similar areas and outdoors as a spot treatment to house foundation walls and around doors and windows for the control of those pests specified on this label.

Precautions: (1) Care should be taken to avoid spotting of walls, or wall coverings, and fabrics (2) When used in dwellings, care should be taken to avoid deposits which could be frequently contacted by children (3) Remove or cover fish bowls and remove pets before spraying (4) Do not allow children or pets in treated areas until surfaces are dry (5) Do not contaminate food, food containers, or cooking utensils (6) Avoid excessive application to carpets (7) Do not apply this product to pets or plants (8) DO NOT use this product in conjunction with motor housings, or electrical switch boxes (9) Do not use as a space spray (10) Do not use in edible product areas of food processing plants, restaurants or other areas where food is commercially prepared or processed (11) Do not use in serving areas which are exposed

HOUSEHOLD PESTS

Cockroaches (Waterbugs), Ants, Silverfish: Make spot applications of D-z-n diazinon 1% EW to baseboards, along ground water pipes, cracks and crevices, surfaces behind and beneath cabinets, refrigerators, sinks, stoves, and similar areas where these insects hide. Spray areas until wet. Repeat application as necessary to maintain control.

Carpet beetles: Spray D-z-n diazinon 1% EW in spot applications along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets and on shelving, and wherever these insects are

Spiders and Scorpions: Spray D-z-n diazinon 1% EW around windows, doors, and along baseboards. Make spot applications to other areas over which these pests may crawl.

Pantry Pests - Exposed Stages (Sawtoothed grain beetle, flour beetle, rice weevil, cigarette beetle, drugstore beetle, Indian meal moth): Spray D-z-n diazinon 1% EW on shelves and in cupboards where food containers suspected of being infested are stored. Remove all food and shelving paper before spraying. Do not replace the food packages until spray has dried. Cover shelves with shelving paper. This treatment is supplemental to good housekeeping, since it will have no effect on insects breeding within food packages. Infested food packages should be destroyed.

Brown dog ticks, fleas*: Apply D-z-n diazinon 1% EW thoroughly to infested areas around baseboards, window and door frames, wall cracks, sleeping quarters of household pets, and localized areas of floors and floor coverings. Fresh bedding should be placed in animal quarters following treatment. Do not treat animals with this product. Repeat as necessary. Avoid excessive wetting of floor coverings, rugs or unfinished material, since damage may occur. Do not apply directly to upholstery. Do not use as an overall space spray.

* Controls adult fleas on areas treated.

OUTDOOR PESTS

House Foundation Treatment

D-z-n diazinon 1% EW will control ants, boxelder bugs, brown dog ticks, chiggers, clover mites, cockroaches, crickets, earwigs, fleas, flies, millipedes, sowbugs, spiders, and collembola (springtails) which are commonly found near the house and may enter the house. Apply as a spot treatment to house foundation walls, around doors and windows and to other areas of the house exterior where these pests are likely to enter. Repeat application as necessary. Do not spray lawns, desirable plants, or shrubbery because plant injury may occur.

Storage and Disposal

Keep from freezing. Store above 32°F. Do not contaminate water. When disposing of equipment wash waters. Do not reuse empty container. Rinse thoroughly before discarding in trash. Securely wrap original container in several layers of newspaper and discard in trash.

Precautionary Statements

Hazards to Humans and Domestic Animals

CAUTION

Harmful if inhaled or absorbed through skin. Avoid contact with skin, eyes, or clothing. Avoid breathing vapors. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse. Remove pets from area, and cover fish bowls before spraying. Keep children and pets off treated areas until the areas are dry.

Statement of Practical Treatment

If in eyes: Flush eyes with plenty of water. Call a physician if irritation persists.

If inhaled: Remove victim to fresh air.

If on skin: Wash with plenty of soap and water.

Note to Physician

Diazinon is an organophosphate insecticide. If symptoms of cholinesterase inhibition are present, atropine sulfate by injection is antidotal. 2-PAM is also antidotal and may be administered but only in conjunction with atropine.

Environmental Hazards

This product is toxic to fish, birds and other wildlife. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on this label.

Physical or Chemical Hazards

Do not use or store near heat or open flame.
