

Break EC is a broad spectrum fungicide for the control of indicated diseases in certain stone fruits and non-bearing citrus.

Important: Do not use in nurseries, on turf, on landscape plantings, or as a tree injection.

Spray Equipment

Thorough coverage is necessary to provide good disease control. Applications using sufficient water volume to provide thorough and uniform coverage generally provide the most effective disease control. For ground equipment, a minimum of 50 gals./A is recommended. For aerial application equipment, a minimum of 5-10 gals./A is recommended, using the higher volume on large trees.

To avoid spray drift, do not apply when conditions favor drift beyond the target area. Avoid spray overlap, as crop injury may occur.

Air assisted or air blast sprayers move spray droplets into the canopy using a forced air stream. Set up the fan to deliver only enough air volume to penetrate the canopy and provide good coverage. Adjust deflectors or other aiming devices to direct spray only to the target area.

Equip sprayers with nozzles that provide accurate and uniform application. Check whirl plates and nozzle discs for wear and replace as necessary. Calibrate sprayer before use.

Use a pump with a capacity to maintain the correct rated pressure for the nozzles selected. Maintain sufficient agitation to keep the mixture in suspension. Use a jet agitator, liquid sparge tube, or mechanical paddle for agitation. Do not air sparge.

Use screens to prevent nozzles from clogging. Screens placed after the tank and before the nozzles should be 50-mesh or coarser. Check nozzle manufacturer's recommendations.

For more information on spray equipment and calibration, consult sprayer manufacturers and state recommendations. For specific local directions and spray schedules, consult the current state agricultural experiment station recommendations.

Mixing Procedures

Prepare no more spray mixture than is required for the immediate operation. Thoroughly clean spray equipment before using this product. Agitate the spray solution before and during application. Rinse spray tank thoroughly with clean water after each day's use and dispose of pesticide rinsate by application to an already treated area.

Break EC Alone: Add $1/2$ - $2/3$ of the required amount of water to the spray or mixing tank. With the agitator running, add the Break EC to the tank. Continue agitation while adding the remainder of the water. Begin application of the spray solution after the Break EC has completely dispersed into the mix water. Maintain agitation until all of the mixture has been sprayed.

Break EC + Tank Mixtures: Break EC is compatible with most recommended insecticides, fungicides, and foliar nutrients.

Do not mix Break EC with Syllit®, or crop injury may occur.

To determine the physical compatibility of Break EC with other products, use a jar test. Using a quart jar, add the proportionate amounts of the products to 1 qt. of water. Add wettable powders first followed by water-dispersible granules, liquid flowables, liquids, and emulsifiable concentrates. After thoroughly mixing, let stand for at least 5 minutes. If the combination remains mixed or can be remixed readily, it is physically compatible. Once compatibility has been established, use the same procedure for adding required ingredients to the spray tank.

Add $1/2$ - $2/3$ of the required amount of water to the spray or mixing tank. With the agitator running, add Break EC and the tank mix partner to the tank in the following order: Add products contained in water-soluble packaging first followed by wettable powders, wettable granules, liquid flowables, liquids, and emulsifiable concentrates. Allow each tank mix partner to completely dissolve and disperse into the mix water before adding the next product. Continue agitation while adding the remainder of the water. Maintain agitation until all the mixture has been applied.

If using Break EC in a tank mixture, observe all directions for use. crops/sites, use rates, dilution ratios, precautions, and limitations which appear on the tank mix product label. APRICOTS, CHERRIES, NECTARINES, PEACHES, PLUMS, AND PRUNES

Stone fruit diseases are most effectively controlled by ground application, using sufficient water volume to provide thorough and uniform coverage.

Notes: (1) Do not apply Break EC to "Stanley" type plums. (2) Do not apply more than 8 fl. oz. of Break EC per acre per crop from early bloom through petal fall. (3) Do not apply more than 8 fl. oz. of Break EC per acre per crop from the end of petal fall to harvest. (4) Do not apply Break EC to prunes after petal fall. (5) East of the Rocky Mountains or to prunes: Do not apply more than 12 fl. oz. of Break EC per acre per crop from early bloom through petal fall.

Brown Rot Blossom Blight (*Monilinia* spp.): Apply 4 fl. oz. of Break EC per acre at early bloom stage (apricots at red bud, cherries at popcorn, peaches and nectarines at pink bud, plums and prunes at green tip). Make a second application of 4 fl. oz./A as needed up through petal fall.

To prunes: Make a second application of 4 fl. oz./A at 50-75% bloom. If blossoming is prolonged or conditions favorable for disease persist, make a third application of 4 fl. oz./A at petal fall.

Powdery Mildew (*Podosphaera* spp.) and Cherry Leafspot (*Blumeriella jaapii*): Follow the brown rot blossom blight schedule. Make up to 2 additional applications on a 10 to 14-day interval from the end of petal fall to harvest.

Fruit Brown Rot (*Monilinia* spp.): Apply as needed a maximum of 2 sprays of Break EC at 4 fl. oz./A during the preharvest period up to the day of harvest (0 day PHI).
