Dear Ms. Bussey:

In reference to your letter dated above, we offer to you the following comments:

On December 10, 1991, in response to your application dated November 12, 1991, we sent a letter to you which indicated that the product referenced above would be processed in accordance with FIFRA section 6(f)(1) for the purpose of a Use Deletion and published in the Federal Register for a period of 90 days. On further consideration we feel that this California restriction does not constitute a deletion of uses. This letter serves as notification to rescind our letter, dated December 10, 1991 regarding Use Deleticn effective the stamped date of this letter.

For your information we wish to point out to you at this time that we do not feel that it is appropriate to offer uses on a label and themtell the user that the product cannot be used for those purposes even though it only applies to one state. You might consider using a separate label when marketing the product in California.

We are also withdrawing our letter dated December 10, 1991 regarding a submission dated August 20, 1991. We understand that Ciba-Geigy made no such submission for this product.

Stamped copy of the labeling submitted with your application dated November 12, 1991 is enclosed for your records. The labeling should be amended at the next printing as follows:

- 1. Delete "Harmful if swallowed" and add the statements "Harmful if absorbed through skin or inhaled. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.
- 2. Add the following to the Statement of Practical Treatment-

If inhaled: Remove victim to fresh air or if not breathing give artificial respiration, preferably mouth to mouth. Get medical attention.

3. At the next label printing, delete the word "natural" from the label found under the heading "How Logic Fire Ant Killer Works". This represents a false or misleading statement to the purchaser and is not in accordance with 40 CFR 156.10 (5)(x)(A).
