) } The proposed amendments referred to above, submitted in connection with registration under The Federal Insecticide, Fungicide, And Rodenticide Act, as Amended are acceptable subject to the comments listed below:

1) The acute oral, acute dermal, acute inhalation, eye irritation, and dermal irritation studies are acceptable as core guideline data. The dermal sensitization study is not acceptable and cannot be upgraded. An acceptable dermal sensitization study must be submitted. Refer to the enclosed review for comments regarding this study.

- 2) Based on the acute data the label must be revised as follows:
 - a) The appropriate signal word is "WARNING".
 - b) The Precautionary Statements must read as follows:
 - "Causes substantial but temporary eye injury. Harmful if swallowed, inhaled, or absorbed through skin. Do not get in eyes or on clothing. Avoid contact with skin and breathing vapor or spray mist. Wear goggles, face shield, or safety glasses when handling. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse."

c) The Statements Of Practical Treatment must read as follows:

"IF IN EYES: Hold eyelids open and flush with a steady, gentle stream of water. Get medical attention.

IF SWALLOWED: Drink promptly a large quantity of milk, eggwhites, gelatin solution, or if thyese are not available, drink large quantities of water. Avoid alcohol. Do not induce vomiting.

IF ON SKIN: Wash with plenty of soap and water. Get medical attention.

IF INHALED: Remove victim to fresh air. If not breathing give artificial respiration, preferably mouth to mouth. Get medical attention.

3) Additional statements may become required after the dermal sensitization study has been submitted and reviewed.

The Confidential Statement Of Formula(CSF) is acceptable and has been placed into the file for this product.


