

## GENERAL INFORMATION

Tilt 428GS is a broad spectrum fungicide for the control of certain diseases in wheat, barley, rye, and grasses grown for seed.

**Note:** Do not use in nurseries, on turf or landscape plantings, or as a tree injection.

### Spray Equipment

Thorough coverage is necessary to provide good disease control. To avoid spray drift, do not apply when conditions favor drift beyond the target area. Avoid spray overlap, as crop injury may occur.

## Tilt® 428GS

Equip sprayers with nozzles that provide accurate and uniform application. Be certain that nozzles are the same size and uniformly spaced across the boom. Calibrate sprayer before use.

Use a pump with capacity to: (1) maintain 35-40 psi at nozzles, and (2) provide sufficient agitation in tank to keep mixture in suspension – this requires recirculation of 10% of tank volume per minute. Use a jet agitator or liquid sparge tube for agitation. Do not air sparge.

Although Tilt 428GS is an emulsifiable concentrate, it is suggested that screens be used to protect the pump and to prevent nozzles from clogging. Screens placed on suction side of pump should be 16-mesh or coarser. Do not place a screen in the recirculation line. Use 50-mesh or coarser screens between the pump and boom, and where required, at the nozzles. Check nozzle manufacturer's recommendations.

For more information on spray equipment and calibration, consult sprayer manufacturers and state recommendations. For specific local directions and spray schedules, consult the current state agricultural experiment station recommendations.

**Aerial Application:** For those crops where aerial applications are indicated, apply in a minimum of 5 gals. of water per acre, unless specified otherwise. Avoid application under conditions when uniform coverage cannot be obtained or when excessive spray drift may occur. Do not apply directly to humans or animals.

**Ground Application:** Apply Tilt 428GS by ground equipment in a minimum of 15 gals. of water per acre.

**Chemigation:** Do not apply this product through any type of irrigation system.

### Mixing Procedures

Thoroughly clean spray equipment before using this product to remove contaminants which may cause crop injury or sprayer clogging. Prepare no more spray mixture than is required for the immediate operation. Agitate thoroughly before and during application, such that a rippling or rolling action is created at the liquid surface. Rinse spray tank thoroughly with clean water after each day's use and dispose of pesticide rinsate by application to an already-treated area.

**Important:** For wheat, barley, and rye, custom applicators must use a closed system for mixing and loading this product.

**Tilt 428GS Alone:** Add  $\frac{1}{2}$ - $\frac{2}{3}$  of the required amount of water to the spray or mixing tank. With the agitator running, add the Tilt 428GS to the tank. Continue agitation while adding the remainder of the water. Begin application of the spray solution after the Tilt 428GS has completely dispersed into the mix water. Maintain agitation until all of the mixture has been sprayed.

**Tilt 428GS + Tank Mixtures:** Tilt 428GS is usually compatible with all tank mix partners listed on this label. To determine the physical compatibility of Tilt 428GS with other products, use a jar test. Using a quart jar, add the proportionate amounts of the products to 1 qt. of water. Add wettable powders and water-dispersible granular products first, then liquid flowables, and emulsifiable concentrates last. After thoroughly mixing, let stand for at least 5 minutes. If the combination remains mixed or can be remixed readily, it is physically compatible. Once compatibility has been proven, use the same procedure for adding required ingredients to the spray tank.

Add  $\frac{1}{2}$ - $\frac{2}{3}$  of the required amount of water to the spray or mixing tank. With the agitator running, add the tank mix partner into the tank. Allow the material to completely dissolve and disperse into the mix water. Continue agitation while adding the remainder of the water and the Tilt 428GS to the spray tank. Allow the Tilt 428GS to completely disperse. Spray the mixture with the agitator running.

If using Tilt 428GS in a tank mixture, observe all directions for use, crops/sites, use rates, dilution ratios, precautions, and limitations which appear on the tank mix partner label. No label dosage rate should be exceeded and the most restrictive label precautions and limitations should be followed. This product should not be mixed with any product which prohibits such mixing. Tank mixtures or other applications of products referenced on this label are permitted only in those states in which the referenced products are registered.

### Rotational Crops

Soybeans may be planted as a double crop following a cereal crop which has been treated with Tilt 428GS. Do not use hay, forage, or fodder from the soybean crop as any component of animal feed or bedding.

To avoid possible illegal residues, do not plant any other crop intended for food, grazing, or any component of animal feed or bedding within 105 days of Tilt 428GS application to the preceding crop, unless the second crop appears on this label.

## CEREALS (FOR USE IN OREGON ONLY)

### Wheat, Barley, Rye

In wheat, barley, and rye, Tilt 428GS controls rusts (*Puccinia* spp.), powdery mildew (*Erysiphe* spp.), leaf blight and glume blotch (*Septoria* spp.), tan spot (*Pyrenophora tritici-repentis*), Helminthosporium leaf blight, barley scald (*Rhynchosporium secalis*), and net blotch (*Pyrenophora teres*). Apply 4 fl. oz. of Tilt 428GS per acre by ground or aerial application. Highest yields are normally obtained when Tilt 428GS is applied to the emerging flag leaf. Tilt 428GS can be applied until the ligule of the flag leaf emerges. (Feekes growth stage 8). Do not apply after this growth stage to avoid possible illegal residues. Tilt 428GS may be applied earlier if disease symptoms appear (especially applicable to barley).

### Tilt® 428GS

For control of foot rot (*Pseudocercospora* spp.), apply 4 fl. oz. of Tilt 428GS per acre plus half rates of other EPA-registered fungicides such as Benlate®, Mertect®, and Topsin® M. Apply at tillering, but before elongation has occurred. Do not apply more than 4 fl. oz. of Tilt 428GS per season.

Do not graze or feed livestock treated forage or cut the green crop for hay or silage. After harvest, the straw may be used for bedding or feed.

#### GRASSES GROWN FOR SEED (FOR USE IN OREGON ONLY)

Tilt 428GS controls rusts (*Puccinia* spp.), powdery mildew, and Selenophoma stem eyespot in perennial ryegrass, fescues, bluegrass, orchardgrass, and/or wheatgrasses.

Mix 4-8 fl. oz. of Tilt 428GS (maximum 4 fl. oz. on bluegrass) in a minimum of 20 gals. of water per acre for ground application, or in a minimum of 10 gals. of water per acre for aerial application. Apply when powdery mildew and Selenophoma infections or rust pustules are noticeable and increasing in number, in late spring or early summer. Repeat at 14 to 21-day intervals. To maximize control under severe rust pressure, use the higher rate of 8 fl. oz./A (except on bluegrass), and make applications at 14-day intervals until the seed is mature. Do not apply more than 32 fl. oz. of Tilt 428GS per acre per growing cycle. Make the last application at least 20 days before seed matures. For bluegrass, it is important to begin application early in the growing season.

**Important:** To avoid possible residues, do not: (1) feed hay cut within 20 days of the last application, or (2) graze treated areas within 140 days of the last application.
