On November 16, 1994, you submitted an amendment request for the addition of the Banner MC brand name and turf and ornamental use pattern registered for EPA Reg. No. 100-641 to EPA Reg. No. 100-741 (the brand name previously associated with this registration record is Alamo®).

The labeling, submitted in connection with registration under FIFRA sec. 3(c)(7)(A), is acceptable provided that you:

1. Submit and/or cite all data required for registration or reregistration of your product under FIFRA sec. 3(c)(5) and sec. 4 when the Agency requires all registrants of similar products to submit such data.
2. Submit five (5) copies of your final printed labeling before you release the product for shipment.

Container Refilling and Disposal

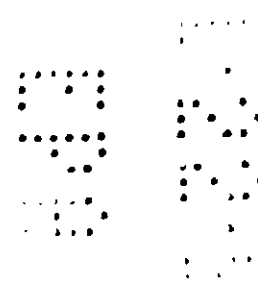
