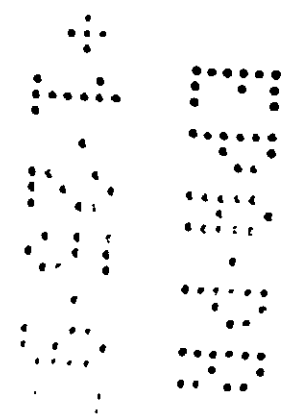

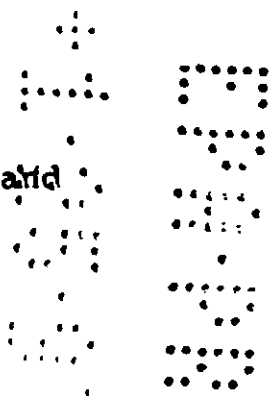

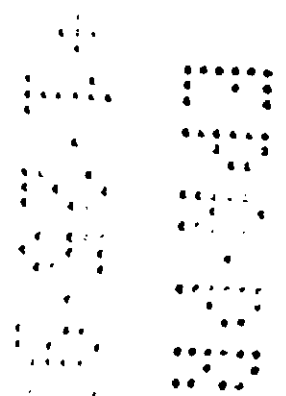
Storage and Disposal
