Subject: Amendment- Add Deer Ticks & Lone Star Ticks
by means of supplemental labeling
D.z.n Diazinon Lawn & Garden WBC
EPA Registration Number 100-770
Your submission dated May 27, 1997

The amendment referred to above, submitted in connection with registrations under FIFRA section 3(c)(7)(a), are acceptable provided that you:

1. Submit and/or cite all data or other material required for registration/reregistration of your products under FIFRA section 3(c)(5) or FIFRA section 4 when the Agency requires all registrants of similar products to submit such data.
2. Make the labeling changes listed below before you release the product for shipment bearing the amended (supplemental) labeling:
 - a) Correct the product name to D.z.n Diazinon Lawn & Garden WBC, rather than D.z.n Diazinon Lawn & Garden Insect WBC.
 - b) Revise the front panel claim "DEER TICKS WHICH MAY CAUSE-LYME DISEASE" to either "DEER TICKS WHICH MAY TRANSMIT LYME DISEASE" or "DEER TICKS WHICH MAY CARRY LYME DISEASE".
 - c) In the Lawn Pest Control Precautions, you may revise "Where irrigation (watering) is recommended..." to just "Where watering is recommended...".
 - d) You may wish to capitalize or to not capitalize the tick names throughout the label for consistency within this label and with your other diazinon labels bearing these same pest claims.

- e) In the lawn application table, you may want to revise the heading to show the full product name D.z.n Lawn & Garden WBC rather than just D.z.n. (you have shown the full product name on the other supplemental labels submitted at this time, plus it will give your customers room in the heading to substitute their product's name). Also, in the same column revise "oz." to "fl. oz." for both pest entries. Likewise, in the conversions listed under the table revise the last entry to read "1 teaspoon = 0.17 fl. oz."
 - e) You may want to add "Do not treat animals with this product." to the end of the Remarks column of the Lawn Pest Control table as you have done at the end of the Nuisance Pests Outside the Home directions.
 - f) In the Nuisance Pests Outside the Home directions, revise the beginning of the first sentence to read "To control deer ticks [or Deer Ticks] which may transmit Lyme Disease," or "To control deer ticks [or Deer Ticks] which may carry Lyme Disease,". Also, you may want to have the Note appear in bold type as it does on other diazinon labels with these same pest directions.
3. Submit three (3) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.

GENERAL INFORMATION

D-z-n Diazinon Lawn & Garden WBC is a water-based concentrate product which must be diluted with water before application. To avoid having spray mixture left over, mix only the amount needed. Refer to the section "How to Mix and Apply" D-z-n diazinon Lawn & Garden WBC works fast and application should be repeated only as directed to maintain control.

Lawn Pest Control

Precautions: Birds, especially waterfowl, feeding or drinking on treated areas may be killed. Apply this product only as specified on this label. Because of the migratory habits of certain waterfowl, do not apply in Nassau County, New York between November 1 and May 20. Do not exceed maximum permitted label rates since rates above those recommended significantly increase potential hazards to birds and waterfowl. Avoid overlapping sprays. When irrigation (watering) is recommended in the directions, or if waterfowl (ducks or geese) can be expected in the treated area after treatment (except spot treatment), water lawn with at least 1/4 inch of water immediately after spraying this product; however stop watering before puddling occurs.

Use on Bent, Bermuda, Bluegrass, Dichondra, Fescue, Merion, and St. Augustinegrass.

To control the deer tick, which may transmit Lyme Disease, and the lone star tick, follow the directions below. Repeat as necessary

<p>Deer Ticks, Lone Star Ticks</p>	<p>To control deer ticks which may cause Lyme Disease, mix 1 1/2 teaspoons in 3 gals. of water. To control the Lone Star Tick, mix 1 teaspoon in 3 gals. of water. Thoroughly spray window and door screens, window sills, foundations, porch and patio walls, entranceways, walks, garbage cans, tree trunks, and into cracks and other places where ticks may hide.</p> <p>To prevent entry into houses, spray a 5-foot band of soil around the house next to the foundation and spray the foundation of the house to a height of 2-3 feet. Repeat application as necessary.</p> <p>Do not treat animals with this product.</p>
