- 5. On page 7 in the box:
  - a. Delete the sentence "Therefore, Syngenta cannot assume...strains of fungi."
  - b. Move the sentence "THIS LABEL IS FOR FIELD USE...PLANT STRUCTURES" out of the box to immediately below the box.

Ridomil Gold MZ contains 4% Ridomil Gold active ingredient and 64% of the active ingredient mancozeb. Ridomil Gold is a systemic fungicide for use on selected crops to control diseases caused by members of the Phycomycete family of fungia. Mancozeb is effective against a wide range of fungal pathogens.

Maximum usage when applying both metalaxyl and mefenoxam containing products to the same crop within the same season. Do not apply more than the maximum seasonal total for the active ingredient as stated on the label of the product containing the lowest seasonal total on that crop.

**Note**: Ridomil Gold MZ contains a systemic fungicide having a specific mode of action and could be subject to development of insensitive strains of fungi. Development of insensitivity cannot be predicted. Therefore, Syngenta cannot assume liability for crop damage resulting from insensitive strains of fungi. ## SPRAY DRIFT MANAGEMENT

A variety of factors including weather conditions (e.g., wind direction, wind speed, temperature, relative humidity) and method of application (e.g., ground, aerial, airblast, chemigation) can influence pesticide drift. The applicator must evaluate all factors and make appropriate adjustments when applying this product.

### Wind Speed

Do not apply at wind speeds greater than 15 mph.

### **Temperature Inversions**

If applying at wind speeds less than 3 mph, the applicator must determine if a) conditions of temperature inversion exist, or b) stable atmospheric conditions exist at or below nozzle height. Do not make applications into areas of temperature inversions or stable atmospheric conditions.

### **Other State and Local Requirements**

Applicators must follow all state and local pesticide drift requirements regarding application of mancozeb. Where states have more stringent regulations, they must be observed.

### Equipment

All aerial and ground application equipment must be properly maintained and calibrated using appropriate carriers or surrogates.

#### Additional requirements for aerial applications:

1. The boom length must not exceed 75% of the wingspan or 90% of the rotor blade diameter.

2. Release spray at the lowest height consistent with efficacy and flight safety. Do not release spray at a height greater than 10 feet above the crop canopy unless a greater. height is required for aircraft safety.

3. When applications are made with a crosswind, the swath must be displaced downwind. The applicator must compensate for this displacement at the up and downwind edge of the application area by adjusting the path of the aircraft upwind.

#### Additional requirements for ground boom application:

1. Do not apply with a nozzle height greater than 4 feet above the crop canopy.

### Mixing Instructions

Prepare no more spray mixture than is needed for the immediate operation. Thoroughly clean spray equipment before using this product. Vigorous agitation is necessary to dissolve the bag and disperse the product. Maintain maximum agitation throughout the spraying operation. Flush the spray equipment thoroughly with water daily after use and dispose of pesticide rinsate by application to an already treated area.

Amount of water needed per acre will vary according to the amount of plant growth. For dilute ground applications, the water volume will vary from 20-150 gals./A. For aerial applications, apply in 5-10 gals. of water per acre. To minimize the potential of drift from target area, applications at wind speeds greater than 10 mph are not recommended. DO NOT USE LESS THAN 5 GALLONS PER ACRE.

Precaution: Water-soluble prepacks of Ridomil Gold MZ must be completely dissolved and dispersed in water before any other tank mix partner, including micronutrients or other liquid or dry fertilizers, are added to the spray solution. Boron, especially in the form of a micronutrient additive, such as Solubor®, etc., or as a natural component of the mix water, may prevent water-soluble bags from dissolving.

**Ridomil Gold MZ Alone**: Add ¼ of the required amount of water to the spray or mixing tank. With the agitator running, drop the required number of **unopened** soluble bags of Ridomil Gold MZ into the tank all at once. Continue agitation while adding the remainder of the water. Begin application of the spray solution after the bags have dissolved, and the material has completely dispersed into the mix water. Maintain agitation until all of the mixture has been applied.

**Ridomil Gold MZ + Tank Mixtures:** Ridomil Gold MZ is usually compatible with Bravo® and Dithane M-45. Add ¼ of the required amount of water to the spray or mixing tank. With the agitator running, drop the required number of **unopened** soluble bags of Ridomil Gold MZ, and any other products packaged in water-soluble bags, into the tank all at once. After the water-soluble bags have dissolved and the products have completely dispersed uniformly into the mix water, continue to fill the tank with water. Then add the desired amount of other products recommended for tank mixture and allow them to become completely dispersed. Continue agitation while adding the remainder of the water and during application to maintain a uniform suspension.

Note: Do not let spray mixture stand overnight in the spray tank. Rinse spray tank at the end of the day.

## **Application Through Irrigation Systems**

Ridomil Gold MZ alone or in combination with other fungicides which are registered for sprinkler irrigation may be applied through irrigation systems.

Apply this product only through center pivot, solid set, hand move, or moving wheel irrigation systems. Do not apply this product through any other type of irrigation system. Crop injury, lack of effectiveness, or illegal pesticide residues in the crop can result from nonuniform distribution of treated water. If you have questions about calibration, you should contact State Extension Service specialists, equipment manufacturers, or other experts. Do not connect an irrigation system (including greenhouse systems) used for pesticide application to a public water system unless the pesticide label-prescribed safety devices for public water systems are in place. - 5. The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.

### **APPLICATION INSTRUCTIONS**

Ridomil Gold MZ must be applied on the schedule specified in the specific crop use directions, not according to the irrigation schedule. If irrigation schedules are used, ground or aerial applications must supplement chemigation applications to achieve adequate disease control.

With the exception of potatoes, Ridomil Gold MZ has not been sufficiently tested to assure consistent product performance for all labeled uses when applied through chemigation systems. The following calibration and application techniques are provided for user reference, but do not constitute a warranty of fitness for application through sprinkler irrigation equipment. Users should check with state and local regulatory agencies for potential use restrictions before applying any agricultural chemical through sprinkler irrigation equipment.

### **Center Pivot Irrigation Equipment**

**Notes:** (1) Use only with drive systems which provide uniform water distribution. (2) Do not use end guns when chemigating Ridomil Gold MZ through center pivot systems because of nonuniform application. (3) Plug the first nozzle closest to well head to protect water source.
