#### **DIRECTIONS FOR APPLICATIONS**

Papaya, Black Sapote, Star Apple, Canistel, Mamey Sapote, Mango, Sapodilla

Use Ridomil Gold Copper to aid in the control of Phytophthora blight caused by Phytophthora palmivora in nurseries, new plantings in the field and on bearing plants.

Apply 2-3 lbs. (1.3 to 1.95 lb. a.i.) of Ridomil Gold Copper per acre as a trunk or foliar spray. Direct the spray to the trunk of the plant or to the fruit column on the trunk. Apply until the point of run-off. When applying to a fruit column use a minimum of 100 gallons of water per acre. Make up to 4 applications at approximately 21 day intervals. Do not apply within 1 day of harvest.

Do not apply Ridomil Gold Copper if Ridomil Gold® EC is used as a soil drench.
