



Only for formulation into a herbicide for the following use(s): corn, cotton, peanuts, pod crops, potatoes, safflowers, sorghum (grain or forage), soybeans, sugar beets, sunflowers, tomatoes, cabbage, peppers (bell, chile, cubanelle, tabasco), alfalfa grown for seed, celery, onions (dry bulb), meadowfoam grown for seed, radishes grown for seed (excluding daikon), buffalograss, guymon bermudagrass for seed production, nurseries, turf, and landscape plantings, peaches, and established grasses grown for seed.

NOTE TO FORMULATORS

Formulators are responsible for providing data to support registration of products formulated from S-metolachlor Technical.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage ~~or~~ and disposal.

Pesticide Disposal

Open dumping is prohibited. Wastes resulting from the use of this product are toxic. Improper disposal of unused pesticide is a violation of federal law. Pesticide that cannot be used according to label instructions must be disposed of according to federal, state, or local procedures. For guidance in proper disposal methods, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office.

Container Disposal/Handling

Refillable container. Refill this container with pesticide only. Do not use this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller. To clean container before final disposal, empty the remaining contents from this container into formulation equipment. Fill the container about 10 percent full with water. Agitate vigorously or recirculate water with the pump for 2 minutes. Pour or pump rinsate into formulation equipment or rinsate collection system. Repeat this rinsing procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke. Thoroughly clean container before reuse.
