Subject: PRIA Label Amendment – IR-4 is submitted a tolerance petition package to support the use of S-metolachlor on chicory (roots and tips), Swiss chard and Stevia. This submission converts tolerances for Vegetable group 5-16 and Brassica subgroup 4-16B (except Chinese broccoli).

The application referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable under FIFRA Section 3(c)(7)(A), subject to the following conditions:

1. You must submit and/or cite all data required for registration/reregistration/registration review of your product under FIFRA when the Agency requires all registrants of similar products to submit such data.
2. You are required to comply with the data requirements described in the DCI identified below:
  - a. S-metolachlor GDCI-108800-1508


A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one (1) copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product

if it bears this new revised labeling or subsequently approved labeling. “To distribute or sell” is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company’s website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. 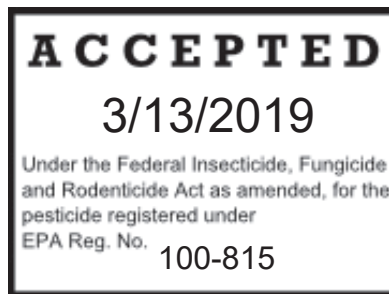

Only for formulation into a herbicide for the following use(s): alfalfa grown for seed; beet, garden, leaves; berries, low-growing (Subgroup 13-07G, excluding cranberry); *brassica*, leafy greens (Subgroup 4-16B); buffalograss; cabbage; celery; cilantro; corn; cotton; cucurbit vegetables (Crop Group 9); revised crop groupings for fruiting vegetables (Group 8-10, except tabasco peppers and excluding okra); established grasses grown for seed; guymon bermudagrass for seed production; head lettuce; horseradish; leaf lettuce; meadowfoam grown for seed, nurseries, turf, and landscape plantings; onions (dry bulb); peaches; peanuts; peppers (bell, chile, cubanelle, tabasco); pod crops (beans, peas, and lentils); potatoes; pumpkin; radishes grown for seed (excluding daikon); rhubarb; safflowers; sorghum (sweet, grain or forage); soybeans; soybean, immature seed; stevia; sugar beets; sugarcane; sunflowers (Subgroup 20B); swiss chard; tomatoes; vegetable, *brassica*, head and stem (Group 5-16); vegetable, leaf petiole (Subgroup 22B); vegetable, leaves of root and tuber (Group 2, except sugar beet); vegetable, root (Subgroup 1B, except carrot); and vegetable, stalk and stem (Subgroup 22A).

Triple rinse as follows: Empty the remaining contents into formulation equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container  $\frac{1}{4}$  full with water and recap. Shake for 10 seconds. Pour rinsate into formulation equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration, or by other procedures approved by state and local authorities.

### **Container Handling [greater than 5 gallons]**

**Non-refillable container.** Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into formulation equipment or a mix tank. Fill the container  $\frac{1}{4}$  full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into formulation equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration, or by other procedures approved by state and local authorities.

### **Container Handling [greater than 5 gallons]**

**Refillable container.** Refill this container with pesticide only. Do not reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the person refilling. To clean container before final disposal, empty the remaining contents from this container into formulation equipment or mix tank. Fill the container about 10 percent full with water. Agitate vigorously or recirculate water with the pump for 2 minutes. Pour or pump rinsate into formulation equipment or rinsate collection system. Repeat this rinsing procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration, or by other procedures approved by state and local authorities.
