SUBJECT: Maxim T Potato Seed Protectant EPA Registration Number 100-821 Your Submission of June 5, 2003

The amendment referred to above, submitted in connection with registration under section (3) of the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA) is acceptable provided you make the following changes:

Precautionary Statements:

Revise the sentence "See additional precautionary statements and directions for use at end of label" which follows the signal word "Caution" to read "See additional precautionary statements and directions for use on label".

Personal Protective Equipment and Agricultural Use Requirements Box:

Replace "waterproof gloves" with "chemical-resistant gloves made out of any water proof material" in the PPE statement and the Agricultural Use Requirements box.

Storage and Disposal:

Add the following sentence to the beginning of the Pesticide Disposal section: "Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility."

Directions for Use - General Information - Mixing Procedures:

In the paragraph beginning "Federal law requires . . ", change the statement "This seed has been treated with fludioxonil fungicide. Store away from feed and foodstuffs." to "This seed has been treated with fludioxonil fungicide. Store away from feed and foodstuffs. Do not use treated seed for food or feed purposes".

Submit one (1) copy of your final printed labeling before you release the product for shipment. A stamped copy of the label is enclosed for your records.

AGRICULTURAL USE REQUIREMENTS

GENERAL INFORMATION

Maxim Potato Seed Protectant is a dry fungicide seed protectant designed to suppress certain fungal diseases of seed potatoes. Maxim Potato Seed Protectant effectively suppresses *Fusarium* dry rot seed decay, seed-borne *Rhizoctonia solani* that causes stem canker and tuber black scurf, and seed-borne *Helminthosporium solani*, the causal agent of silver scurf disease on potato tubers. It does not control bacterial disease nor diseases present within the seed.

Maxim Potato Seed Protectant is to be used as an integral part of a potato disease management strategy. This strategy includes the use of high quality certified seed and the incorporation of cultural techniques such as: crop rotation and optimal harvest time for tubers to minimize disease development; proper handling of tubers without bruising. The practices should also include management and sanitation of equipment and storage areas to reduce disease inoculum. In addition, appropriate storage management practices that maintain appropriate temperature, ventilation, and relative humidity to avoid free moisture or condensation must be carried out. Consult your local

agricultural extension agent for more detailed information on disease management practices.

DO NOT USE ON SEED TO BE PLANTED FOR THE PRODUCTION OF SEED.

Note: Fludioxonil is a fungicide with a specific mode of action that could be subject to development of less sensitive strains of fungi. Development of insensitivity cannot be predicted. Therefore, Syngenta cannot assume liability for crop damage resulting from insensitive strains of fungi. Consult your State Agricultural Experiment Station or Extension Service Specialist for guidance on your particular disease control situation.

Mixing Procedures

Use Maxim Potato Seed Protectant at the rate of 0.5 lb. of product per 100 lbs. of seed pieces. Apply using equipment that ensures uniform and thorough coverage of each seed piece. Periodically clean and sanitize all surfaces of cutting (e.g., cutting machines, knives, tables), as well as planting equipment and planters thoroughly, before cutting and planting seed pieces. After cutting, treated seed pieces should be planted in soil above 45°F with adequate soil moisture required for planting. If cut seed needs to be stored or held for a few days (7 days or less), make sure that there is adequate cool air (60°F) movement through the pile of cut seed potatoes at relative humidity of 85-90%. Cut and treated seed should not be piled above 6 ft. in height. When transporting cut and Maxim-treated seed, make sure the seed is covered.

Do not use treated seed pieces for food or feed purposes.

Apply only in areas with adequate ventilation and/or dust collection and control equipment.

Federal law requires that bags containing treated seed shall be labeled with the following information: "This seed has been treated with fludioxonil fungicide. Store away from feed and foodstuffs." Use an EPA-approved dye or colorant that imparts an unnatural color to the seed.
