Subject: Dividend<sup>™</sup> XL RTA® Fungicide EPA Registration Number 100-826 Your label amendment application dated July 11, 2006 for decision D369338 that adds Barley seed treatment to the label and makes other labeling changes, and a related submission dated April 16, 1997.

We have reviewed the subject amended labeling, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended. The amended labeling is acceptable provided that:

1. You submit to the Agency each of the following studies or materials by its stated due date.

a. Submit, by December 31, 2007, storage stability data for the processed commodities of apples (wet pomace and juice) and grapes (raisin and juice) that reflect the longest storage intervals reported in the respective processing studies. This is 17.5 months for apples, 14.2 months for grape juice, and 4.2 months for raisins.

b. Submit, by July 31, 2008, a Soil Photolysis study (Guideline Requirement No. 161-3; OPPTS 835.241). Both the natural and the artificial sunlight studies that were submitted were not scientifically valid and did not provide useful information on the photodegradation

of Difenoconazole in sandy loam soil. Since soil degradation, aquatic degradation, and degradation by hydrolysis is slow, but degradation by aqueous photolysis is relatively fast, soil photolysis may be an important route of degradation. Understanding this route would provide a better characterization of the fate of Difenoconazole in the environment, especially of its availability for runoff into water bodies.

c. Submit, by July 31, 2008, a study that determines the toxicity of Difenoconazole residues to benthic organisms. The environmental fate and effects risk assessment does not estimate risk for sediment dwelling organisms because such a toxicity study was not provided. Because Difenoconazole is persistent and has a high Koc, its residue concentrations in sediment are expected to be higher than those in the water column. You are encouraged to contact the Agency concerning the specific type and protocol of study that would be most useful in this regard.

2. You make and submit, by July 31, 2007, the changes to the confirmatory residue analytical method that have been recommended by EPA's Analytical Chemistry Laboratory (ACL), and this revised method is then determined by the Agency to be suitable for tolerance enforcement.

3. Submit one copy of your final printed master and supplemental labels before you release product bearing this amended labeling for shipment.

The Agency also requests that the French and Swiss versions of the product label for Score® 250 EC/Slick® 250 EC be amended to specify a post-harvest interval (PHI) for grapes. Available data will support a 55-day PHI.

In the Agency's risk assessment for 1,2,4-triazole and its metabolites triazole alanine, and triazole acetic acid, dated February 7, 2006 (see docket number 2005-0497 at http:// ww.regulations.gov), the Agency identified additional data that are needed for triazole-derivative active ingredients which have the 1,2,4,-triazole ring. The Agency plans to issue a Data Call-In for all triazole-derivative active ingredients which will identify all data needs for these active ingredients listed in the February 7, 2006 risk assessment. The Data Call-In will not address data needs that are related to parent-only data requirements.
