Subject: Mertect 40 Antimycotic EPA Registration No. 100-887 Your label amendment application (notification) dated April 2, 1998

Dear Mr. Pence,

The amended labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided that you:

- 1. Make the following changes to the label:
 - a. Add a "Storage" subsection to the "STORAGE AND DISPOSAL" section. Include in this section such statements as are appropriate to protect the integrity of the product and its container, what to do if there is a spill, etc.
 - b. In the "Hazards to Humans and Domestic Animals" section, add the following sentence after "Do not get in eyes or on skin.":

"Wash thoroughly with soap and water after handling."

c. In the "First Aid" section, separate the "If in eyes or on skin into two sections and word them as follows:

> "If in eyes: Flush eyes with plenty of water. Call a physician [you can also add "if irritation persists]."

"If on skin: Wash with plenty of soap and water. Get medical attention if irritation persists."

d. Move the language in the paragraph directly before the section title "Environmental Hazards" to the appropriate "Storage" or "Disposal" subsection.

In the "Environmental Hazards" section, if this product e. is not intended for outdoor use, delete the sentence

"Do not apply directly to water."

If the product is intended for outdoor use, modify the same sentence to read:

"Do not apply directly to water, or to areas where surface water is present, or to intertidal areas below the mean high water mark."

Submit one copy of your final printed labeling before you 2. release the product for shipment.

If these conditions are not complied with, the registration may be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.



DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

For each 100 lbs, of bone-dry tobacco, suspend 2.4 oz, of Mertect 40 in the tobacco water stream. Then proceed as usual with the preparation of the reconstituted tobacco leaf.

STORAGE AND DISPOSAL

Disposal

Prohibitions

Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited. Do not reuse empty container.

Pesticide Disposal

Pesticide, spray mixture, or rinsate that cannot be used according to label instructions must be disposed of according to federal, state, or local procedures under the Resource Conservation and Recovery Act.

Container Disposal

Completely empty liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment. Then dispose of liner and fiber drum in a sanitary landfill or by incineration if allowed by state and local authorities.

General

Consult federal, state, or local disposal authorities for approved alternative procedures such as limited open burning.
