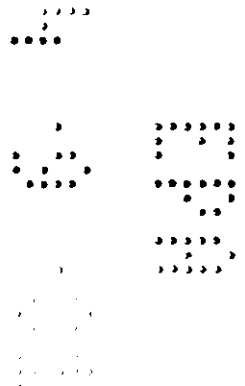

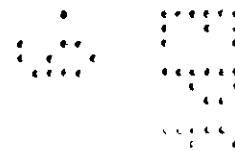
General
