GENERAL INFORMATION

Fulfill is an insecticide for the control of certain aphid species in cucurbit vegetables, fruiting vegetables, potato (and other tuberous and corm vegetables), and tobacco.

Apply Fulfill to plant foliage when aphids first appear, before populations build to damaging levels.

Thorough spray coverage is essential for best performance. Apply Fulfill in sufficient water to ensure good coverage of all plant surfaces. The use of greater water volumes will generally result in better coverage, especially under adverse conditions (e.g., hot, dry) or where a dense plant canopy exists. See the **Recommended Applications** section of this label for specific recommendations on spray volumes for different crops.

Ground Spray Equipment

Use sufficient water to provide thorough, uniform coverage.

Use sprayer nozzles that provide accurate, uniform application and medium-sized droplets.

Calibrate sprayer from manufacturer's instructions or state's recommendations to ensure delivery of adequate spray volume per unit area.

Applications using sufficient water volume to provide thorough and uniform coverage generally provide the most effective aphid pest control. For ground applications, use the minimum spray volume indicated in the **Recommended Applications** section of this label.
