GENERAL INFORMATION

Fulfill Insecticide is an insecticide for the control of certain aphid species in cotton, hops, pecans, potatoes (and other tuberous root and corm vegetables), tobacco, and vegetables.

Apply Fulfill Insecticide to plant foliage when aphids first appear, before populations build to damaging levels.

Thorough spray coverage is essential for best performance. Apply Fulfill Insecticide in sufficient water to ensure good coverage of all plant surfaces. The use of greater water volumes will generally result in better coverage, especially under adverse conditions (e.g., hot, dry) or where a dense plant canopy exists. The rotational (plantback) restriction for Fulfill Insecticide is 30 days for all crops.

Ground Spray Equipment

Use sufficient water to provide thorough, uniform coverage.

Use sprayer nozzles that provide accurate, uniform application and medium-sized droplets.

Calibrate sprayer from manufacturer's instructions or state's recommendations to ensure delivery of adequate spray volume per unit area.

The pesticide injection pipeline must also contain a functional, normally closed, spendid-operated valve located on the intake side of the injection pump and contracted to the system interlock to prevent fluid from being withdrawn from the subjuty tank when the irrigation system is either automatically or manually shut down.
- 5. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops.
- 6. Tite irrigation line or water pump must include a functional pressure switch that will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.
- 7. Systems must use a metering pump, such as a positive displacement injection pump (e.g., diaphragm pump), effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.
- 8. Do not apply when wind speed favors drift beyond the area intended for treatment.

Calibration and Application Instructions

Fulfill Insecticide should be applied under the schedule specified in the specific crop use recommendations, not according to the irrigation schedule unless the events coincide.

In general, set the equipment to apply the minimum amount of water per acre. Run the system at 30-95% of the manufacturer's maximum rated travel speed.

The following calibration and application techniques are provided for user reference, but do not constitute a warranty of fitness for application through sprinkler irrigation equipment. Users should check with state and local regulatory agencies for potential use restrictions before applying any agricultural chemical through sprinkler irrigation equipment.

Center Pivot Irrigation Equipment

- 2. Determine the time required to apply 0.1-0.25 inches of water over the area to be treated when the system and injection equipment are operated at normal pressures as recommended by the equipment manufacturer. Run the system at 80-95% of the manufacturer's rated maximum travel speed.
- 3. Using water, determine the injection pump output when operated at normal line pressure.
- 4. Determine the amount of Fulfill Insecticide, and any tank mix partners, required to treat the area covered by the irrigation system.

- 6. Make sure the system is fully charged with water before starting injection of the Fulfill Insecticide solution. Time the injection to last at least as long as it takes to bring the system to full pressure.
- 7. Maintain constant agitation in the solution tank during the injection period.
- 8. Inject the specified amount of Fulfill Insecticide per acre continuously for one complete revolution of the system.
- 9. Stop the injection equipment after treatment is completed. Continue to operate the system until the Fulfill Insecticide solution has cleared all of the sprinkler heads.
- 10. Allow time for all lines to flush the pesticide through all nozzles before turning off irrigation water.

Solid Set, Hand Move, and Moving Wheel Irrigation Equipment

- 1. Determine the acreage covered by the sprinklers.
- 2. Fill injector solution tank with plain water and calibrate the flow rate of the system to deliver the contents of the tank over a 20-40 minute time interval.
- 3. Determine the amount of Fulfill Insecticide required to treat the area covered by the irrigation system.
- 4. Add the required amount of Fulfill Insecticide, and any other tank mix partners, into the same quantity of water used to calibrate the injection period. (See the **MIXING PROCEDURES** section of this label.)

- 5. Operate the system at the same pressure and time interval established during the calibration.
- 6. Injust specified amount of Fulfill Insecticide per acre for either a 20-40 minute period at the end of a regular irrigation set, or as a 20-40 minute injection as a separate application not associated with a regular irrigation to maximize retention of the insecticide by the foliage.
- 7. Stoc injection equipment after treatment is completed. Continue to operate the system until the Fulfill Insecticide solution has cleared the last sprinkler head. To ensure lines are flushed and free from remaining pesticides, a dye indicator may be injected into the lines to mark the end of the application period.

MIXING PROCEDURES

Prepare no more spray mixture than is needed for the immediate application. Thoroughly clean spray equipment before using this product. Agitate the spray solution before and during application. Do not let the spray mixture stand overnight in the spray tank. Fluen the spray equipment thoroughly following each use and apply the rinsate to a previously treated area. Keep product container tightly closed when not in use.

Fulfill Insecticide Alone: Add ¹/₂ of the required amount of water to the mix tank. With the agitator running, add the Fulfill Insecticide to the tank. Follow manufacturer's instructions for cleaning/maintaining PPE. If no such instructions exist for washables, use detergent and hot water. Keep and wash PPE separately from other laundry.

Engineering Control Statements

When handlers use closed systems, enclosed cabs, or aircraft in a manner that meets the requirements listed in the Worker Protection Standard (WPS) for agricultural pesticides [40 CFR 170.240(d)(4-6)], the handler PPE requirements may be reduced or modified as specified in the WPS.

User Safety Recommendations

Users should:

- Wash hands before eating, drinking, chewing gum, using tobacco, or using the toilet.
- Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing.

Environmental Hazards

No. 100-912) which corrects the Early Re-entry PPE to read "Coveralls" instead of "Long-sleeved shirt and long pants". In conversations with the EPA on January 14, 2004, it was requested that Syngenta make this change to the label because it was brought to the EPA's attention that "long-sleeved shirt and long pants" is the same PPE required for applicators and other handlers and early re-entry PPE is required to be more protective. This change will be incorporated into the next final printed version of labeling for the Amendment accepted by EPA on December 17, 2003.
