

Helix XTra is a seed treatment product that contains both insecticide and fungicide components with activity against flea beetles and certain seed borne and damping off diseases of canola. Thiamethoxam, the insecticide component, provides activity against flea beetles and the remaining components are fungicides with activity against damping off diseases caused by *Pythium* spp., *Fusarium* spp., *Rhizoctonia* spp, and seed-borne blackleg (*Leptosphaeria maculans*). Thiamethoxam, difenoconazole, (R)-[(2,6-dimethylphenyl)-methoxyacetylamino]-propionic acid methyl ester, and fludioxonil are the active ingredients in Cruiser® 5FS, Dividend®, Apron XL® LS, and Maxim® 4FS, respectively.

Note: (R)-[(2,6-dimethylphenyl)-methoxyacetylamino]-propionic acid methyl ester is a systemic fungicide having a specific mode of action. #### **MIXING PROCEDURES**

Helix XTra is especially formulated as a ready to apply seed treatment. An EPA-approved coloring agent, C.I. Pigment Blue No. 15, has been added to the formulation. No additional colorant, dyes, binders, or water are needed. Helix XTra has a density of 10.77 pounds per gallon. Apply utilizing standard slurry seed treatment equipment which provides uniform seed coverage. Uneven or incomplete seed coverage may not give the desired level of insect or disease control. Consult the manufacturer of the application equipment you plan to use for suitability for this application and for instructions on operation and calibration of the equipment. Allow seed to dry before bagging.


