On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A) provided that you:

- 1. Submit and/or cite all data required for registration/ reregistration of your product under FIFRA sec. 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregistration of your product under FIFRA section 4.
- 2. Make the labeling changes listed below before you release the product for shipment:
  - a. Add the phase "EPA Registration No. 100-979".
- 3. Submit two (2) copies of your final printed labeling before you release the product for shipment.
- 4. You have requested under section 6(f) of FIFRA that this registration be voluntarily canceled on a date not later than June 30, 2003. EPA intends to cancel all new diazinon outdoor non-agricultural use MUP registrations, including this registration, effective June 30, 2003, and the Agency does not contemplate permitting sale, distribution, or use of existing stocks after that date, except for return to the Registrant (i.e., you) for purposes of relabeling, export, or disposal.

5. In accordance with the December 5, 2000 Memorandum of Agreement between the Environmental Protection Agency and Syngenta Crop Protection, Inc. and Makhteshim Chemical Works, Ltd., regarding the registration of pesticide products containing diazinon (i.e., the Diazinon MOA dated December 5, 2000):

# Sale/Shipment Limitations:

- (A) You have provided EPA with a specification of a quantity of your diazinon manufacturing use product which EPA has accepted as the "Baseline Quantity" for your future limitations as set forth herein, which constitutes an estimate of the total quantity of all diazinon active ingredient for outdoor non-agricultural uses sold, shipped to a customer, or incorporated into another of your registered products.
- (B) For each calendar year for the next three years, you will not sell, ship to a customer, or incorporate into another of your registered products any more new diazinon outdoor non-agricultural use MUP than the quantities specified in this paragraph.
- (1) For the calendar year 2001, you will not sell, ship to a customer, or incorporate into another of your registered products more new diazinon outdoor non-agricultural use MUP than your Baseline Quantity
- (2) For the calendar year 2002, you will not sell, ship to a customer, or incorporate into another of your registered products more new diazinon outdoor non-agricultural use MUP than 75% of your Baseline Quantity.
- (3) For the calendar year 2003, you will not sell, ship to a customer, or incorporate into another of your registered products more new diazinon outdoor non-agricultural use MUP than 50% of your Baseline Quantity.
- (4) You will not sell, ship to a customer, or incorporate into another of your registered products any new diazinon outdoor non-agricultural use MUP after June 30, 2003.
- (C) You will meet with EPA to discuss your sale/shipment limitations specified in subparagraph 5(B) of the Diazinon MOA should EPA determine that it may approve additional new diazinon outdoor non-agricultural use MUP registrations.
- (D) On or before January 31, 2002; January 31, 2003; and June 1, 2003 you shall submit to the Agency a report stating the volume of your new diazinon outdoor non-agricultural use MUP registrations sold, shipped to a customer, or incorporated into another of your registered products in calendar years 2001, 2002 and 2003, respectively.

- 6. Notification to Future Purchasers. You shall provide at the time of each purchase notification of the relevant terms and dates of the Product Recovery Program as stated in paragraph 6 of the December 5, 2000 Memorandum of Agreement between the Environmental Protection Agency and Syngenta Crop Protection, Inc. and Makhteshim Chemical Works, Ltd., regarding the registration of pesticide products containing diazinon to anyone who directly purchases your new diazinon outdoor non-agricultural use MUP. Furthermore, as a condition of its sale of each new diazinon outdoor non-agricultural use MUP, you must require the purchaser to provide to the purchaser's distributors and/or retail establishments, as applicable, notice of the terms and dates of the Product Recovery Program outlined in paragraph 6 of the Diazinon MOA dated December 5, 2000.
- 7. Reporting. You shall submit to EPA a list of the purchasers of your respective new diazinon outdoor non-agricultural use MUPs for each twelve month period beginning with the period January 1, 2001 to December 31, 2001 and ending with the period January 1, 2003 to December 31, 2003. You shall submit this list to EPA within thirty (30) calendar days of the conclusion of the preceding twelve month period.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

- a. Package Sizes
  - 1. Formulation of this product into any concentrated liquid diazinon product is prohibited unless the formulated product is packaged in quantities not greater than one quart.
- b. Reformulation, Sales, and Distribution Dates
  - 1. After December 31, 2001, this product may not be formulated into another product unless the registrant of that product has submitted to the EPA a request to voluntarily cancel the registration pursuant to Section 6(f) of FIFRA on a date no later than December 31, 20004 and the registration of the reformulated product has been amended in the interim to incorporate the following conditions of registration:
    - 1) the registrant may not manufacture, label, or release for shipment the reformulated product after June 30, 2003;
    - 2) The registrant may not sell or distribute reformulated product after August 31, 2003.
    - 3) The registration of the reformulated product will expire and be canceled on December 31, 2004.
    - 4) The registrant of the reformulated product will send to every seller who purchases its product a notification of the Product Recovery Program to be conducted by Syngenta Crop Protection, Inc. and Makhteshim Chemical Works, Ltd. after December 31, 2004.
    - 5) Unless the label of the reformulated product expressly prohibits reformulation or repackaging of that product, the reformulated product must include on its label all of the restrictions contained in subparagraphs 3((A), 3(B), and 3(C) of Section I of the Memorandum of Agreement

## 4. REQUIRED PRECAUTIONS TO REDUCE RISK TO BIRDS

## SPECIAL PRECAUTIONS TO REDUCE RISKS TO BIRDS

Birds, especially waterfowl (ducks or geese), feeding or drinking on treated areas may be killed. To reduce risks to birds:

- A. Do not treat areas larger than 15,000 sq. ft.
- B. Because of the migratory habits of certain waterfowl, do not apply in Nassau County, New York between November 1 and May 20.
- C. Do not exceed maximum permitted label rates, since rates above those recommended significantly increase potential hazards to birds, especially waterfowl.
- D. Avoid overlapping treated areas.
- E. Follow all watering instructions included within the directions for use; however, stop watering before puddling occurs.
- F Do not apply this product to sites occupied by waterfowl or to sites within 75 ft. of any body of water that may attract waterfowl, such as lakes or ponds.



- G. If necessary to repeat application, wait a minimum of 3 weeks between applications. Make no more than 4 applications per year.
- 2. Granular formulations with greater than 5% active ingredient may NOT be used on lawns.
- 3. The maximum use rate on lawns is 4.3 lbs. a.i. per acre.
- 4. For foundation band treatments around house foundations, the band must be no wider than 2 ft, and the use rate no greater than 4.3 lbs. a.i. per acre.
