

Cockroaches, Spiders, Crickets, Scorpions, Silverfish, Ticks and Firebrats



Apply around doors and windows and similar areas where these, or similar perimeter, pests may be found or where they may enter premises. Apply to baseboards, storage areas and other locations. Apply barrier treatments to prevent infestation as described below; also see **Outdoor Surfaces Use**.
