Dear Mr. Pearson:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable, subject to the comments listed below.

- 1. The Agency has reviewed the cited acute oral toxicity study (MRID 45698201) submitted in support of Syngenta's request to change the signal word from Warning to Danger, and found it to be acceptable. The signal word for EPA Reg No. 100-1013 has been changed from Warning to Danger.
- 2. The respirator statement needs to be updated as per PR Notice 98-9.
- 3. Please add "and other aquatic organisms" to the "Environmental Hazards" section.
- 4. You have only listed cotton under the uses for terrestrial food. You must list all crops with tolerances.
- 5. In the warranty statement, please change "In no event" to "To the extent permitted by law, Syngenta or Seller shall not be liable..."
