Container Handling (refillable)

Refillable container Refill this container with pesticide only Do not reuse this container for any other purpose Cleaning the container before final disposal is the responsibility of the person disposing of the container Cleaning before refilling is the responsibility of the refiller. To clean the container before final disposal empty the remaining contents from this container into formulation equipment. Fill the container about 10 percent full with water.
