Examples of such structures include homes and other permanent or temporary residences food processing facilities industrial and commercial buildings trash receptacles transport vehicles (ships trains aircraft) docks and port of terminal buildings and related structures around and associated with these sites. Fence and perimeter baiting beyond 100 feet from a structure as defined above is prohibited. This product must not be applied directly to food or feed crops. Do not broadcast bait

Determine areas where rats and/or mice will most likely find and consume the bait Generally these areas are along walls by gnawed openings in corners and concealed places between floors and walls or in locations where rodents or their signs have been observed Remove as much food as possible

Norway and Roof Rats

Apply 4–16 bait packs (usually at intervals of 15–30 ft) per placement Maintain an uninterrupted supply of fresh bait for 10 days or until signs of rat activity cease

House Mice

Apply 1 bait pack per placement Space placements at intervals of 8 12 ft Two bait packs may be needed at points of very high mouse activity Maintain an uninterrupted supply of fresh bait for 15 days or until signs of mouse activity cease
