Apply 1 bait pack per placement. Space placements at intervals of 8-12 ft. Two bait packs may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for 15 days or until signs of mouse activity cease.

Rats and Mice

Replace contaminated or spoiled bait immediately. Collect and dispose of all dead rodents and left over bait properly. To prevent reinfestation, limit sources of rodent food, water, and harborage as much as possible. Where a continuous source of infestation is present, maintain permanent bait stations and replenish with census or toxic bait as needed.
