On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act. Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

Based on your response to the Rodenticide Cluster Reregistration Eligibility Decision, EPA has reregistered the product listed above. This action is taken under the authority of section 4(g)(2)(C) of the Federal Insecticide, Fungicide, and Rodenticide Act, as amended. Reregistration under this section does not eliminate the need for continual reassessment of pesticides. EPA may require submission of data at any time to maintain the registration of your product.

Generic data requirements that have been identified in the RED as confirmatory data for the active ingredient contained in the subject product will continue to be tracked and assessed in the Agency's continual reassessment of pesticides.

1. On the Front Panel, change "Rodents may consume a lethal dose in one feeding with first dead rodents appearing four or five days after treatment begins." to:

Norway rats and house mice may consume a lethal dose in one night's feeding with first dead rodents appearing four or five days after feeding begins.

- 2. Wherever it occurs on your labeling, change "NOT FOR RESALE" to "INDIVIDUAL SALE PROHIBITED BY LAW".
- 3. Revise your "PRECAUTIONARY STATEMENTS" as follows:

PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals

CAUTION: Harmful if swallowed or absorbed through the skin. Keep away from children, domestic animals and pets. Do not get in eyes, on skin, or on clothing.

TREATMENT FOR PET POISONING

If animal eats bait, call veterinarian or HOT LINE NUMBER at once.

NOTE TO VETERINARIAN

Anticoagulant Brodifacoum: For animals ingesting bait and/or showing poisoning signs (bleeding or elevated prothrombin times), give Vitamin K_1 at doses of 2-5 mg/kg. If needed, check prothrombin times every 3 days until values return to normal (up to 30 days). In severe cases, blood transfusions may be needed.

Environmental Hazards

WeatherBlok Bait with Bitrex may also be used in transport vehicles (ships, trains, aircraft) and in and around related port or terminal buildings. This product may also be used in alleys and sewers.

IMPORTANT: Do not expose children, pets, or nontarget animals to rodenticides.

Use Restrictions

- Store product not in use in a location out of reach of children and pets.
- When used in residential structures this product must be applied in tamper resistant bait stations. All above ground, outdoors applications must be in tamper resistant bait stations. These stations must be resistant to destruction by dogs and by children under 6 years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from stations when they are lifted, units must be secured or otherwise immobilized. Even stronger bait stations are needed in areas open to hoofed livestock, raccoons, bears, or other potentially destructive animals, or in areas prone to vandalism.

Selection of Treatment Areas

Determine areas where rats and/or mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been observed. Remove as much food as possible.

APPLICATION DIRECTIONS

Norway and Roof Rats

Apply 4 - 22 (20 g (0.7 oz)) blocks of WeatherBlok Bait with Bitrex (usually at intervals of 15-30 ft.) per placement. Maintain an uninterrupted supply of fresh bait for 10 days or until signs of rat activity cease.

For use in sewers, securely attach one end of wire to WeatherBlok Bait with Bitrex and the other end to a stationary structure such as the bottom step of a manhole ladder or to a sewer grate, allowing just enough wire for the block to rest on manhole benching. If benching is not present, suspend block a few inches above the high water line or place WeatherBlok Bait with Bitrex on a board supported by opposing steps of the ladder. Securing WeatherBlok Bait with Bitrex in this manner will prevent removal by rats or water. Maintain an uninterrupted supply of fresh bait for at least 10 days or until signs of rat activity cease.

House Mice

Use 1 bait block per placement. Space placements at intervals of 8-12 ft. Two blocks may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for 15 days or until signs of mouse activity cease.

Rats and Mice

Replace contaminated or spoiled bait immediately. Collect and dispose of all dead animals and (when baiting operations are to be ceased) unconsumed bait according to the **Disposal** paragraph. To prevent reinfestation, limit food, water and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish or maintain bait stations and replenish with census or toxic bait as needed.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage

Store only in original container in a dry place inaccessible to children and pets.

Pesticide Disposal
