Dear Mr. Wells:

The labeling referred to above is acceptable provided you make the following changes to the label:

- 1. To the Warranty section add "to the extent consistent with applicable law" in front of "syngenta makes no warranties", "in no event shall sygenta", and "the exclusive remedy".
- 2. To the crop list change "glyphosate tolerant" to "roundup ready". To the crop list, you must list berries, fruits, nuts, vines, small grains, and vegetables as specified in 40 CFR 180.364.

You must submit a copy of the final printed label. A stamped copy of the label is enclosed for your records. This label supersedes all previously accepted labels. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA. 
