The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable provided the following changes are made.

1. On page 1, change the heading "Active Ingredients" to "Active Ingredient".
2. On page 3, within the second paragraph of the Environmental Hazards section, capitalize the "s" on "system" prior to "(NPDES)". Also within this section, change "with" to "without" in the second to last sentence starting "Do not discharge".
