After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6. STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

Pesticide Storage

Keep container tightly closed when not in use. Keep away from heat and flame. Do not store near seed, fertilizers, or foodstuffs. Can be stored at temperatures as low as minus 20°F. Open dumping is prohibited.

Waste resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Handling

Triple rinse as follows: Empty the remaining contents into formulation equipment. Fill the container ¼ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into formulation equipment or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.
