Dear Ms Strader

Thank you for contacting us regarding the recent error in the July 5 2012 label amendment requirements for the product cited above. Please note that we have removed the requirement that the warranty statement be revised to more closely follow the Label Review Manual guidelines. This decision was based on the 2008 documentation from EPA's Office of General Counsel indicating that such changes were not required since Syngenta is seeking standardization of their label warranty language.

Please note that the updated Agency letter removing the requirement that warranty language be amended retains the date on the original Agency letter of July 5 2012 in order to avoid both internal and external confusion. This revised letter citing the appropriate required label revisions will be uploaded to the Pesticide Product Label System and will be accessible to the general public and state regulatory partners.



I am also enclosing page 1 of the approved label with legible date and EPA Registration Number.
