

Dear Mr. McCain,

This letter replaces the letter concerning the same product and subject that was sent to you on March 3, 2006. The original letter contains an error in paragraph 1.f. and several typographical errors which are corrected in this replacement letter.

The amended labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable provided that you:

1. Make the following changes to the label:

a. In the Ingredient Statement, change the CAS designation for Mefenoxam from "(CAS No. 70630-17-0)" to "CAS No. 70630-17-0 and 69516-34-3)".

b. In the in the first bulleted item in the "User Safety Recommendations" section, change "...eating, drinking chewing gum, using..." to "...eating, drinking, chewing gum, using...".

c. In the "CONDITIONS OF SALE AND LIMITATION OF WARRANTY AND LIABILITY" section, qualify the extent of liability of "Syngenta or Seller" by adding a clause similar to "To the extent allowed by law,". However, this may not be further qualified by limiting "law" to "State law".

d. In the third to the last sentence in the first paragraph of the "GENERAL INFORMATION" section, change "...appear on the tank, mix partner label..." to "...appear on the tank mix partner label...".

e. In the last sentence in the first paragraph of the "GENERAL INFORMATION" section, change "...mixed with any product, which prohibits..." to "...mixed with any product which prohibits...".

f. Change the "GENERAL USE PRECAUTIONS" section to read "Cotton may be replanted immediately after an azoxystrobin treatment. Do not plant any other crop within 45 days after the last treatment of the cotton crop with a product that contains azoxystrobin or after the planting of cotton seeds that have been treated with a product that contains azoxystrobin."

g. IN the third sentence in the third paragraph of the
"MIXING INSTRUCTIONS" section, near the bottom of page 7, change
"...completely disperse prior by adding Dynasty CST..." to
"...completely disperse prior to adding Dynasty CST...".

2. Submit one copy of your final printed label before you release product bearing this amended labeling for shipment.

b. In the in the first bulleted item in the "User Safety Recommendations" section, change "...eating, drinking chewing gum, using..." to "...eating, drinking, chewing gum, using...".

c. In the "CONDITIONS OF SALE AND LIMITATION OF WARRANTY AND LIABILITY" section, qualify the extent of liability of "Syngenta or Seller" by adding a clause similar to "To the extent allowed by law,". However, this may not be further qualified by limiting "law" to "State law".

d. In the third to the last sentence in the first paragraph of the "GENERAL INFORMATION" section, change "...appear on the tank, mix partner label..." to "...appear on the tank mix partner label...".

e. In the last sentence in the first paragraph of the "GENERAL INFORMATION" section, change "...mixed with any product, which prohibits..." to "...mixed with any product which prohibits...".

f. Change the "GENERAL USE PRECAUTIONS" section to read "Peanuts may be replanted immediately after an azoxystrobin treatment. Do not plant any other crop within 45 days after the last treatment of the peanut crop with a product that contains azoxystrobin or after the planting of peanut seeds that have been treated with a product that contains azoxystrobin."

IN the third sentence in the third paragrapy of the **a**... "MIXING INSTRUCTIONS" section, near the bottom of page 7, change "...completely disperse prior by adding Dynasty CST..." to "....completely disperse prior to adding Dynasty CST...".

2. Submit one copy of your final printed label before you release product bearing this amended labeling for shipment.

GENERAL INFORMATION

Dynasty CST is a broad spectrum, preventative seed treatment fungicide with systemic and contact properties recommended for the control of many important plant diseases. Dynasty CST may be applied in tank mixes, or sequentially with other registered, seed treatment products. If using Dynasty CST in a tank mixture with other seed treatment products, observe all directions for use, crops/sites, use rates, dilution ratios, precautions, and limitations, which appear on the tank, mix partner label. No label dosage should be exceeded and the most restrictive label precautions and limitations should be followed. This product should not be mixed with any product, which prohibits such mixing.





All applications should be made according to the use directions that follow. If a rate range is specified, use higher rates of Dynasty CST when the disease pressure is expected to be high.

GENERAL USE PRECAUTIONS

Cotton may be replanted immediately after last treatment. Do not plant other crops within 45 days after last application.

RESISTANCE MANAGEMENT

GROUP 4 411 12 FUNGICIDES

Dynasty CST is a mixture of a Group 4 (melenoxam),a Group 11 (azoxystrobin), and a Group 12 (Fludioxonil) fungicide: Dynasty CST has three modes of action: (1) Phenylamides- affects RNA Synthesis [Group 4], (2) inhibitor of the Qo (quinone outside) site within the electron transport system (QoI) as well as disrupting membrane synthesis by blocking demethylation [Group 11] and (3) a Phenylpyrrole [Group 12] fungicide. The potential for resistance to non-systemic seed treatment fungicides is extremely low. Systemic seed treatments have the ability to move through the shoot and into the growing plant. If the concentration of the systemic fungicide applied to the seed is low, the potential concentration that could move into the plant would be minimal and would not have any impact on foliar pathogens and resistance. Low rate seed treatments can be followed by a foliar fungicide treatment with the same fungicide chemistry if it is applied at least 3 weeks after planting. Follow the resistance management guidelines for all foliar applications. For fungicide chemistry where there is documented resistance on a specific crop, use a different fungicide chemistry for the first foliar application.

MIXING INSTRUCTIONS

Apply Dynasty CST as a water based slurry using seed treatment application equipment that will provide uniform coverage on the seed surface. Consult the manufacturer of the application equipment being used for calibration and operation procedures.

Dynasty CST mixes easily with water and other water based seed treatments manufactured by Syngenta. When mixing with products from other manufacturers, the compatibility should be tested prior to use by conducting a jar test. Mix all intended seed treatments with the appropriate amount of water in a clear glass container. Mix well and let sit for one hour. Remix and observe for incompatibility.

Mixing Dynasty CST with tank mix partners: Add ½ of the required water to the mix tank and turn on the agitation. Mechanical agitation is preferred. If using wettable powders and/or products in water-soluble pouches, add them first to clean water allowing them to completely disperse prior by adding Dynasty CST or other products. Allow each tank mix partner to completely disperse before adding the next product. Add the remaining amount of water and agitate. Maintain agitation until the entire slurry mixture has been used. Allow seed to dry prior to bagging.

Note: Federal law requires that bags of treated seeds shall be labeled with the following information. "This seed has been treated with azoxystrobin, fludioxonil, and metenoxam

fungicides. Do not use for food, feed or oil purposes. Store away from food and feedstuffs." Use with an EPA-approved dye that imparts an unnatural color to the seed.
