4. Make the labeling changes listed below before you release the product for shipment.
  - a. Add the phrase "EPA Registration No. 100-1183".
  - b. For consistency with the CSFs revise the active ingredient statement to read "glyphosate, N-(phosphonomethyl)glycine, in the form of the **monopotassium** salt.
  - c. Modify the footnote to the active ingredient statement to give the number of pounds per US gallon of glyphosate acid **equivalents**.


