Such a claim could constitute misbranding under section 156.10(a) (5)(v) as it could "directly or undirectly imply the this pesticide product is recommended or endorsed by an Agency of the Federal Government or a municipality."

 - Established perennials and wildflower plantings
 - Plants grown for cut foliage production (Florida only)
 - Non-crop areas, including plantings on or surrounding municipal grounds and government installations, managed rights-of-way for transportation systems and utilities (including, roadways, roadsides, railways and equipment yards)
 - Facilities including substations, tank farms, pumping stations, parking and storage areas, and ungrazed fence rows
