On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act. Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A) provided that you:

1. Submit and/or cite all data required for registration of your product under FIFRA Section 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for re-registration of your product under FIFRA Section 4.
2. Before releasing the product for shipment revise the EPA Registration Number to read, "EPA Reg. No. 100-1228" to your label before you release the product for shipment.
3. Submit a GLP storage and stability study (830.6317) and corrosion characteristics study (830.6320) by March 30, 2007.


4. Submit a final printed label which makes the following changes:
 - A. Under the section "Precautionary Statements" change: "Do not get in eyes or on clothing", to "Do not get in eyes, on skin, or on clothing." Also, insert: "Wear protective clothing and gloves."
 - B. On page 2 delete the redundant statement: "Do not get in eyes".
 - C. Delete "May cause skin sensitization on repeated contact", as the only statement required is already present.
 - D. Product label for 'Prime +' must list the EPA registration number globally.
 - E. On page 5 delete "This product may not be used or referenced...from Syngenta." FIFRA does not allow such restriction of sale statements. We have blacked out this statement on the attached stamped label.
5. "Environmental Hazards" section of the label must include the sentence: "This product is toxic to fish." Sentence containing 'NPDES' must read as: "...in a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge." Additionally, "public" must be changed to "other".
6. Beneath "Storage and Disposal", in the first sentence, include: "Open burning and dumping is prohibited."
7. Under the section "Conditions of Sale and Limitation of Warranty..." revise statements beginning with: "All such risks shall be assumed by Buyer and User..." and "In no event shall Syngenta or Seller..." to read: "To the extent permitted by law...". As currently written the statement negates and/or detracts from labeling requirements as set forth by the Agency in 40 CFR Part 156, and is, therefore, considered misbranding." For consistency it's recommended that the section "Conditions of Sale and Limitation of Warranty..." replace "Storage and Disposal" as the final label section.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release of the shipment of your product constitutes acceptance of these conditions.

A copy of the label stamped "Accepted with comments" is enclosed for your records.

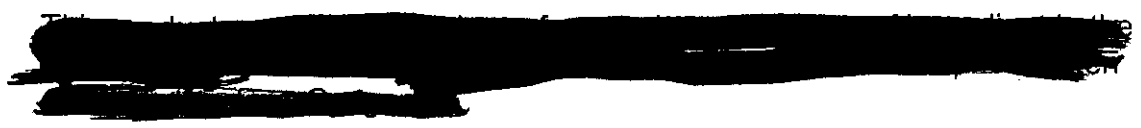
