### PROTECTION OF AQUATIC AREAS

Force CS Insecticide contains a Group 3 insecticide (tefluthrin). Insect biotypes with acquired or inherent resistance to Group 3 insecticides may eventually dominate the pest population if Group 3 insecticides are used repeatedly as the predominant method of control for targeted species. This may result in partial or total loss of control of those species by Force CS Insecticide or other Group 3 insecticides.



If resistance to this product develops in your area, this product, or other products with a similar mode of action, may not provide adequate control. If poor performance cannot be attributed to improper application or extreme weather conditions, a resistant strain of insect may be present. ## APPLICATION PROCEDURES

---

### DIRECT INJECTION APPLICATIONS

Follow application equipment manufacturer's directions for spray preparation and calibration to deliver the correct Force CS Insecticide rates.

### DILUTE APPLICATIONS

#### **Spray Preparation**

When determining application volumes, ensure that at least 2 gallons of spray volume per acre is applied.

To prepare for spraying, fill tank to approximately  $\frac{1}{2}$  the needed volume of water or other agricultural products (See **Mixing with Other Agricultural Products**) and start agitation. Transfer the proper amount of Force CS Insecticide into tank. Agitate to ensure thorough mixing for a minimum of 2 minutes or until product is thoroughly dispersed and then add the remaining diluent volume. Product mixtures should be agitated continuously during use. Avoid allowing tank contents to remain without agitation for periods of greater than 1 hour. When tank contents have remained without agitation for 1 hour or longer, agitate contents for at least 10 minutes before starting applications. Avoid allowing large quantities of product mixtures (greater than 5 gallons) to be stored in non-agitated tanks for extended periods of time, such as 12 hours or greater.

#### **Mixing with Other Agricultural Products**

While Force CS Insecticide has good flexibility for tank mixing with other agricultural products, a jar test for physical compatibility is recommended for untried mixtures using proper ratios and mixing sequences of all ingredients to be included in the mixture.

Force CS Insecticide is an aqueous-based formulation. Do not use any type of non-emulsifiable oils in combination with Force CS Insecticide. If adjuvants are used, use only:

Nonionic Surfactant (NIS) containing at least 75% surface agent or Non-phytotoxic Crop Oil Concentrate (COC), including once refined Vegetable Oil Concentrate (VOC), or Methylated Sunflower Oils (MSO) containing a minimum of 17% emulsifier.

Adjuvants other than NIS or COC may be used providing the product meets the following criteria:

1. Contains only EPA-exempt ingredients.
2. Is non-phytotoxic to the target crop.

3. Is compatible in mixture. (May be established through a jar test.)
4. Is supported locally for use with Force CS Insecticide on the target crop through proven field trials and through university and extension recommendations.

In addition, the following may be used as diluents:

- Crop Oil Concentrate
- Methylated Sunflower Oils
- Urea-Ammonium Nitrate

It is recommended that the following not be used in combination with Force CS Insecticide as diluents or adjuvants:

- Non-emulsifiable oils
- Diesel Fuel
- Straight Mineral Oil

## CROP USE DIRECTIONS

---

### At Planting T-Band Treatment

Apply Force CS Insecticide at planting time for the control of corn rootworms, cutworms, lesser corn stalk borer, seedcorn beetles, seedcorn maggots, white grubs, and wireworms. **Liquid T-band** applications are to be placed in a 7-inch T-band across the open seed furrow between the furrow openers and the press wheels. T-band applications need to be followed by an incorporation of 1 inch into the soil either by using tines, press wheels, closing wheels, or other suitable equipment which are either attached to the planter or part of the planter system.

**DO NOT** apply this product as a T-band unless you can incorporate the product as directed above. This will improve insect control and reduce the potential for adverse effects to aquatic organisms.

### At Planting In-Furrow Treatment

Apply Force CS Insecticide at planting time as an in-furrow treatment for control of corn rootworms, seedcorn maggots, white grubs, and wireworms. **Liquid in-furrow applications** are to be applied into the seed furrow, through spray nozzles or microtubes, behind the planter furrow openers, and in front of the press wheels.

The at-planting treatments described above ensure that there is a zone of root protection which is approximately 7 inches wide and 5 inches deep.

The zone of protection is the area around and within the corn root where Force CS Insecticide has activity against seed-, plant- and root-feeding insects. By controlling

early-season insect feeding, Force CS Insecticide provides protection for developing corn root systems.

<sup>1</sup> For use only in field corn that contains at least a single corn rootworm trait. In cases of high populations of corn rootworm, or in suspected areas of corn rootworm resistance to corn rootworm traits, the level of control may only reach suppression. The level of control of other insect pests may also be reduced with these lower rates.

### Rotational Crop Restrictions

Rotational crops may be planted no sooner than 30 days after application.

### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

#### Pesticide Storage

Store in original containers only. Keep container closed when not in use. Do not store near food or feed. In case of spill or leak on floor or paved surfaces, soak up with sand, earth, or synthetic absorbent. Remove to chemical waste area. **DO NOT ALLOW PRODUCT TO FREEZE.**

#### Pesticide Disposal

**Container Handling (5 gallons or less)**

**Non-refillable container.** Do not reuse or refill this container. Offer for recycling if available. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container  $\frac{1}{4}$  full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use and disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then offer for recycling if available or puncture and dispose of empty container in a sanitary landfill, or by incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.

**Container Handling (Bulk/Mini-Bulk)**

**Refillable container.** Refill this container with pesticide only. Do not reuse the container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the person refilling. To clean container before final disposal, empty the remaining contents from this container into application equipment or mix tank. Fill the container about 10 percent full with water.
