- 4. Submit the results of one year storage stability and corrosion characteristic studies to EPA within one year of this date of registration. Submit a hard copy and an electronic copy also.
- 5. Submit by January 2, 2012 the following Study conducted on accordance with the Good Laboratory Practice Standards, 40 CFR Part 160 and appropriate test guidelines as referenced in EPA's Data Requirements for Registration Regulations, 40 CFR Part 158:
 - Immunotoxicity Study (OPPTS 780.7800)


