PRODUCT INFORMATION

Vibrance CST is a broad-spectrum seed treatment fungicide containing four active ingredients: Azoxystrobin, Fludioxonil, Mefenoxam, and Sedaxane. All four of these active ingredients have a different mode of action against fungal pathogens. Vibrance CST protects cotton against damage from the Seedling Disease Complex: Damping-off, Seedling Blight, Seed Rot, and Root Rot caused by *Fusarium* species, *Pythium* species, and *Rhizoctonia* species.

Azoxystrobin is active against *Rhizoctonia* species causing seedling damping-off and *Pythium* species causing seedling blight in cotton.

Fludioxonil is active against *Fusarium* and *Rhizoctonia* species in cotton.

Mefenoxam is active against *Pythium* species causing damping-off and seed rot in cotton.

Sedaxane is active against *Rhizoctonia* species causing seed decay, seedling blight and damping-off in cotton.

RESISTANCE MANAGEMENT

GROUP 4 7 11 12 FUNGICIDES

Vibrance CST contains mefenoxam, a Group 4 fungicide; sedaxane, a Group 7 fungicide; azoxystrobin, a Group 11 fungicide; and fludioxonil, a Group 12 fungicide. Mefenoxam belongs to the phenylamide class of chemistry which interferes with fungal RNA synthesis. Sedaxane is a succinate dehydrogenase inhibitor (SDHI) and belongs to the carboxamide class of chemistry which disrupts cellular respiration and energy generation. Azoxystrobin belongs to the strobilurin class of chemistry which disrupts cellular respiration and energy generation. Fludioxonil belongs to the phenylpyrrole class of chemistry which interferes with osmotic signal transduction.

Fungal populations may contain individuals naturally resistant to Group 4, 7, 11, or 12 fungicides and if used repeatedly in the same fields, then resistant members may eventually dominate the population. Because resistance development cannot be predicted, the use of this product should conform to sound resistance management strategies such as alternation with fungicides with a different mode of action and/or tank mixes established for the crop and use area.

Use should be based on an IPM program that includes field sanitation, scouting, historical information related to pesticide use, and crop rotation. The IPM program should also consider cultural, biological, and other chemical control practices.

Syngenta encourages responsible product stewardship to ensure effective long term control of the fungal diseases on this label.

MIXING PROCEDURES

Important: Always re-circulate Vibrance CST thoroughly before using.

Follow the manufacturer's application instructions for the seed treatment equipment being used.

Apply Vibrance CST as a water-based slurry utilizing standard slurry seed treatment equipment which provides uniform seed coverage. Uneven or incomplete seed coverage may not give the desired level of disease control. Thoroughly mix the specified amount of Vibrance CST into the required amount of water or liquid inoculant for the slurry treater and dilution rate to be used.

Certain crops require addition of inoculants when the seed is treated or planted. Vibrance CST is compatible with several liquid inoculant products. Consult the maker of the inoculant product and a Syngenta representative for directions before applying Vibrance CST with inoculants.

The total application volume must be sufficient to provide desired level of coverage. Dilution is typically done with water or liquid inoculants.

Continuous agitation or mixing of the slurry mixture is necessary to prevent settling out of the solution. Clean out any unused product from the treater after treating or maintain constant agitation if the leftover slurry will be maintained overnight.

- Use an EPA-approved dye or colorant that imparts an unnatural color to the seed as required in 40 CFR 153.155(c).
- Allow seed to dry before bagging.

SEED CONTAINER LABEL REQUIREMENTS

The Federal Seed Act requires that containers of treated seeds shall be labeled with the following statements:

- This seed has been treated with Azoxystrobin, Fludioxonil, Mefenoxam, and Sedaxane fungicides.
- Do not use for feed, food, or oil purposes.

In addition, the U.S. Environmental Protection Agency requires the following statements on containers of seeds treated with Vibrance CST:

- Ground Water Advisory: Azoxystrobin, Mefenoxam and a degradate of Azoxystrobin are known to leach through soil into groundwater under certain conditions as a result of label use. Fludioxonil has properties and characteristics associated with chemicals detected in groundwater. These chemicals may leach into groundwater if used in areas where soils are permeable, particularly where the water table is shallow.
- Store treated seed away from feeds and foodstuffs.
- Do not allow children, pets, or livestock to have access to treated seed.
- Wear long-sleeved shirt, long pants and chemical-resistant gloves when handling treated seed.
- Treated seed must be planted into the soil at a depth greater than 1 inch.
- Treated seeds exposed on soil surface may be hazardous to wildlife. Cover or collect treated seeds spilled during loading and planting.
- Dispose of all excess treated seed. Leftover treated seed may be double-sown around the headland or buried away from water sources in accordance with local requirements.
- Do not contaminate water bodies when disposing of planting equipment washwaters.
- Dispose of seed packaging in accordance with local requirements.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage

Store in the original container and only in a cool, dry, secure place.

Pesticide Disposal

Wastes resulting from the use of this product must be disposed of on site or at an approved waste disposal facility. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency or the Hazardous Waste Representative at the nearest EPA regional office for guidance.

Container Handling [less than or equal to 5 gallons]

Non-refillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration, or by other procedures approved by state and local authorities.

Container Handling [greater than 5 gallons – mini-bulk]

Non-refillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration, or by other procedures approved by state and local authorities.

Container Handling [greater than 5 gallons – bulk]

Refillable container. Refill this container with pesticide only. Do not reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the person refilling. To clean container before final disposal, empty the remaining contents from this container into application equipment or mix tank. Fill the container about 10 percent full with water. Agitate vigorously or recirculate water with the pump for 2 minutes. Pour or pump rinsate into application equipment or rinsate collection system. Repeat this rinsing procedure two more times.
