The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Azoxystrobin, Fludioxonil and Mefenoxam Interim Decisions, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Use is permitted in commercial seed treatment facilities. Use is also permitted on-farm, except in the state of California. In the state of California, use is restricted to commercial seed treatment facilities only. Do not use for at-plant applications (e.g. hopper box, planter box, etc.). This product is to be applied as a water-based slurry through standard slurry- or mist-type commercial seed treatment equipment.

Store between a range of 32°F to 100°F.

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulation.

## AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. #### PRODUCT INFORMATION

Vibrance CST is a broad-spectrum seed treatment fungicide containing four active ingredients: Azoxystrobin, Fludioxonil, Mefenoxam, and Sedaxane. All four of these active ingredients have a different mode of action against fungal pathogens. Vibrance CST protects cotton against damage from the Seedling Disease Complex: Damping-off, Seedling Blight, Seed Rot, and Root Rot caused by *Fusarium* species, *Pythium* species, and *Rhizoctonia* species.

Azoxystrobin is active against *Rhizoctonia* species causing seedling damping-off and *Pythium* species causing seedling blight in cotton.

Fludioxonil is active against *Fusarium* and *Rhizoctonia* species in cotton.

Mefenoxam is active against *Pythium* species causing damping-off and seed rot in cotton.

Sedaxane is active against *Rhizoctonia* species causing seed decay, seedling blight and damping-off in cotton.

For resistance management, please note that Vibrance CST contains Group 4/mefenoxam, Group 7/sedaxane, Group 11/azoxystrobin and Group 12/fludioxonil fungicides. Any fungal population may contain individuals naturally resistant to Vibrance CST and other Group 4, Group 7, Group 11 or Group 12 fungicides. A gradual or total loss of pest control may occur over time if these fungicides are used repeatedly in the same fields. Appropriate resistance-management strategies should be followed.

Mefenoxam belongs to the phenylamide class of chemistry which interferes with fungal RNA synthesis. Sedaxane is a succinate dehydrogenase inhibitor (SDHI) and belongs to the carboxamide class of chemistry which disrupts cellular respiration and energy generation. Azoxystrobin belongs to the strobilurin class of chemistry which disrupts cellular respiration and energy generation. Fludioxonil belongs to the phenylpyrrole class of chemistry which interferes with osmotic signal transduction.

To delay fungicide resistance, take one or more of the following steps:

- Rotate the use of Vibrance CST or other Group 4, Group 7, Group 11, or Group 12 fungicides within a growing season sequence with different groups that control the same pathogens.
- Use tank mixtures with fungicides from a different group that are equally effective on the target pest when such use is permitted. Use at least the minimum application rate as labeled by the manufacturer.
- Adopt an integrated disease management program for fungicide use that includes scouting, uses historical information related to pesticide use, and crop rotation, and which considers host plant resistance, impact of environmental conditions on disease development, disease thresholds, as well as cultural, biological and other chemical control practices.
- Where possible, make use of predictive disease models to effectively time fungicide applications. Note that using predictive models alone is not sufficient to manage resistance.
- Monitor treated fungal populations for resistance development.

#### MIXING PROCEDURES

**Important:** Always re-circulate Vibrance CST thoroughly before using.

Follow the manufacturer's application instructions for the seed treatment equipment being used.

Apply Vibrance CST as a water-based slurry utilizing standard slurry seed treatment equipment which provides uniform seed coverage. Uneven or incomplete seed coverage may not give the desired level of disease control. Thoroughly mix the specified amount of Vibrance CST into the required amount of water or liquid inoculant for the slurry treater and dilution rate to be used.

Certain crops require addition of inoculants when the seed is treated or planted. Vibrance CST is compatible with several liquid inoculant products. Consult the maker of the inoculant product and a Syngenta representative for directions before applying Vibrance CST with inoculants.

The total application volume must be sufficient to provide desired level of coverage. Dilution is typically done with water or liquid inoculants.

Continuous agitation or mixing of the slurry mixture is necessary to prevent settling out of the solution. Clean out any unused product from the treater after treating or maintain constant agitation if the leftover slurry will be maintained overnight.

- Use an EPA-approved dye or colorant that imparts an unnatural color to the seed as required in 40 CFR 153.155(c).
- Allow seed to dry before bagging.

# SEED CONTAINER LABEL REQUIREMENTS

The Federal Seed Act requires that containers of treated seeds shall be labeled with the following statements:

- This seed has been treated with Azoxystrobin, Fludioxonil, Mefenoxam, and Sedaxane fungicides.
- Do not use for feed, food, or oil purposes.

In addition, the U.S. Environmental Protection Agency requires the following statements on containers of seeds treated with Vibrance CST:

- Groundwater Advisory: Azoxystrobin, Mefenoxam and a degradate of Azoxystrobin are known to leach through soil into groundwater under certain conditions as a result of label use. Fludioxonil has properties and characteristics associated with chemicals detected in groundwater. These chemicals may leach into groundwater if used in areas where soils are permeable, particularly where the water table is shallow.
- Store treated seed away from feeds and foodstuffs.
- Do not allow children, pets, or livestock to have access to treated seed.
- Wear long-sleeved shirt, long pants and chemical-resistant gloves when handling treated seed.
- Treated seed must be planted into the soil at a depth greater than 1 inch.
- Treated seeds exposed on soil surface may be hazardous to wildlife. Cover or collect treated seeds spilled during loading and planting.
- Dispose of all excess treated seed. Leftover treated seed may be double sown around the headland or buried away from water sources in accordance with local requirements.
- Do not contaminate water bodies when disposing of planting equipment washwaters.
- Dispose of seed packaging in accordance with local requirements.
- Excess treated seed may be used for ethanol production only if:
  - (1) By-products are not used for livestock feed, and

- For any other crops the minimum plantback interval is 30 days from the date seeds treated with Vibrance CST were planted.
- The maximum application rate is not to exceed 0.00018 lb ai/seed of azoxystrobin.
- **DO NOT** apply more than 0.01 lb ai/Acre/calendar year (4.7 g ai/Acre/calendar year) of mefenoxam as a seed treatment on Cotton.
- **DO NOT** apply more than 0.125 lb ai/Acre/calendar year (56.7 g ai/Acre/calendar year) of mefenoxam regardless of type of application (seed treatment, soil or foliar) on Cotton.

#### **RESTRICTIONS:**

#### STORAGE AND DISPOSAL

# **Pesticide Storage**

Store in the original container and only in a cool, dry, secure place. Store between a range of 32°F to 100°F.

# **Pesticide Disposal**

Wastes resulting from the use of this product must be disposed of on site or at an approved waste disposal facility. # **Container Handling [less than or equal to 5 gallons]**

Non-refillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration, or by other procedures approved by state and local authorities.

#### Container Handling [greater than 5 gallons]

Non-refillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ½ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration, or by other procedures approved by state and local authorities.

# Container Handling [greater than 5 gallons]

**Refillable container.** Refill this container with pesticide only. Do not reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the person refilling. To clean container before final disposal, empty the remaining contents from this container into application equipment or mix tank. Fill the container about 10 percent full with water.
