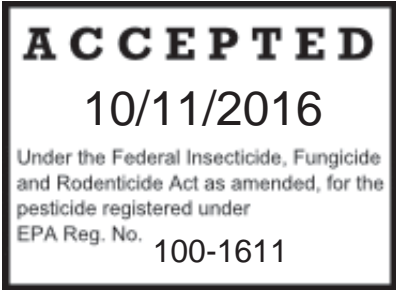

2.0 PRECAUTIONARY STATEMENTS

2.1 Hazards to Human and Domestic Animals

WARNING

May be fatal if swallowed or inhaled. Do not breathe vapor or spray mist. Harmful if absorbed through the skin. Causes moderate eye irritation. Avoid contact with skin, eyes, or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco, or using the toilet. Remove and wash contaminated clothing before reuse.

2.2 Personal Protective Equipment (PPE)

Applicators and other handlers must wear:

- Long-sleeved shirt and long pants
- Chemical-resistant gloves made of any waterproof material

2.2.1 USER SAFETY REQUIREMENTS

Discard clothing and other absorbent materials that have been drenched or heavily contaminated with this product's concentrate. Do not reuse them. Follow manufacturer's instructions for cleaning/maintaining PPE. If no such instructions for washables exist, use detergent and hot water. Keep and wash PPE separately from other laundry.

2.2.2 ENGINEERING CONTROLS

When handlers use closed systems or enclosed cabs, in a manner that meets the requirements listed in the worker Protection Standard (WPS) for agricultural pesticides (40 CFR 170.240(d)(4-6)), the handler PPE requirements may be reduced or modified as specified in the WPS.

2.3 Environmental Hazards

This pesticide is toxic to fish and wildlife.

Do not contaminate water when disposing of equipment wash water or rinsate. This product is highly toxic to bees exposed to direct treatment on blooming crops or weeds. Do not apply this product or allow it to drift to blooming crops or weeds while bees are foraging in or adjacent to the treatment area.

Use of this product may pose a risk to threatened and endangered species of fish, amphibians, crustaceans (including fresh water shrimp), and insects. A level, well-maintained vegetative buffer strip between areas to which this product is applied and surface water features such as ponds, streams, and springs will reduce the potential loading of abamectin from runoff water and sediment. Runoff of this product will be reduced by avoiding applications when rainfall is forecast to occur within 48 hours.

2.4 Physical or Chemical Hazards

Do not use or store near heat or open flame.

RESTRICTED USE PESTICIDE

3.0 PRODUCT INFORMATION

- Divanem is a soluble concentrate containing abamectin which, when applied according to directions for use, will control turf-parasitic nematodes on golf courses.
- Divanem should be applied as a seasonal program.
- Apply Divanem as an early curative treatment (after appropriate nematode extraction, identification, and counts).
- Multiple applications may be required before improvements in turf quality are observed
- Maximum annual rate must not exceed 0.27 lb abamectin/calendar year or 50 fl oz Divanem/A/calendar year.

4.0 APPLICATION DIRECTIONS

4.1 Application Equipment

For best results, use spray nozzles that produce extremely coarse droplets [such as Turbo Floodjet (TF5) or TurfJet (TTJ10)].

4.2 Mixing Directions

4.2.1 DIVANEM ALONE

Add the required amount of product directly to the spray tank and mix well.

4.2.2 TANK-MIX PRECAUTIONS

- Do not combine Divanem in the spray tank with pesticides, surfactants, or fertilizers unless compatibility charts or your own prior use has shown that the combination is physically compatible, effective, and non-injurious under your conditions of use.
- Do not mix with any product that prohibits such mixing.
- Observe all directions for use, sites, use rates, dilution ratios, precautions, and limitations that appear on the tank-mix product label.
- Do not exceed any labeled use rate.
- Follow the most restrictive label precautions and limitations.
- Tank mixtures or other applications of products referenced on this label are permitted only in those states in which the referenced products are labeled.

4.2.3 TANK-MIX COMPATIBILITY

Divanem is compatible with Daconil Action™, Banner MAXX®, Headway®, Heritage® TL, Heritage® Fungicide, Heritage™ Action, Subdue MAXX®, and Velista®turf fungicides.

4.2.4 SPRAY ADDITIVES

The addition of a soil surfactant or soil wetting agent is recommended with Divanem. Follow all manufacturer use rates, recommendations, and restrictions.

5.0 RESTRICTIONS AND PRECAUTIONS

5.1 Use Restrictions

- **DO NOT** apply to golf course roughs.
- **DO NOT** apply to residential turf, sports fields or commercial turf.
- **DO NOT** use aerial application.
- **Chemigation: DO NOT** apply this product through any type of irrigation system.
- **DO NOT** apply through an ultra-low volume spray system.
- **DO NOT** apply to turf under heat or moisture stress.
- **DO NOT GRAZE TREATED TURF OR FEED TURF CLIPPINGS FROM ANY TREATED AREA TO POULTRY OR LIVESTOCK.**

5.2 Spray Drift Management

DO NOT spray when conditions favor drift beyond area intended for application. Conditions which may contribute to drift include thermal inversion, wind speed and direction, sprayer nozzle/pressure combinations, spray droplet size, etc. Contact your State extension agent for spray drift prevention guidelines in your area.

AVOIDING SPRAY DRIFT IS THE RESPONSIBILITY OF THE APPLICATOR. **DO NOT** apply when weather conditions favor drift from treated areas to non-target aquatic habitat.

7.0 STORAGE AND DISPOSAL

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

Pesticide Storage
